	Information to national Parliaments				

- 1. On 20 October 2015, the Commission submitted to the Council draft amending budget (DAB) No 8 to the general budget for 2015.
- In order to allow the Council to adopt a position on DAB No 8/2015¹ without delay, the 2. Council has to decide, considering the urgency of the matter, to shorten, in accordance with Article 3(3) of its Rules of Procedure, the eight-week period laid down in Article 4 of Protocol No 1 on the role of national Parliaments in the European Union.
- 3. National Parliaments have to be informed thereof.

The Council position on DAB No 8/2015 shall contain a recital stating that "in order to facilitate Member States' cash flow management at year-end and alleviate the financial burden on national treasuries in a timely manner, draft amending budget No 8 to the general budget for 2015 needs to be adopted without delay. Therefore, it is justified to shorten, in accordance with Article 3(3) of the Council's Rules of Procedure, the eight-week period for the information of national Parliaments laid down in Article 4 of Protocol No 1.".

- 4. Accordingly, the <u>Permanent Representatives Committee</u> is requested to suggest that the Council:
 - decide, on the basis of Article 3(3) of its Rules of Procedure, to shorten the eight-week
 period for the information of national Parliaments laid down in Article 4 of
 Protocol No 1 on the role of national Parliaments in the European Union;
 - approve the attached communication to be addressed to national Parliaments by the
 General Secretariat of the Council.
