d) Detailed grounds for the transfer

Following the adoption of the Commission Proposal for a Council Decision COM(2015)466 of 30/09/2015 and the Commission Proposal for a Council Decision COM(2015)471 of 01/10/2015, the legislative procedures for the entry into force of the Sustainable Fisheries Partnership Agreements (SFPA) with the Republic of Liberia and the Islamic Republic of Mauritania are ongoing and are expected to be finalised by mid-November 2015. The timeline for ensuring the availability of necessary appropriations in 2015 means that the proposal for transfer from the reserve line has to be launched before the formal adoption of the two Council Decisions. Therefore, it is proposed to transfer the necessary appropriations (commitments and payments) from the reserve line 40 02 41 to the operational line 11 03 01 to allow for the commitment and payment of the first instalments under the above mentioned Protocols.

From the total transfer proposal of EUR 59 840 000 (commitments), EUR 715 000 relates to the SFPA with Liberia and EUR 59 125 000 is necessary for the SFPA with Mauritania.

From the total transfer proposal of EUR 55 357 500 (payments), EUR 357 500 relates to the SFPA with Liberia and EUR 55 000 000 is necessary for the SFPA with Mauritania.

The difference between commitment and payment appropriations needed is due to the fact that the sectoral support for Mauritania (EUR 4 125 000) and for Liberia (EUR 357 500) will be committed in 2015 but paid in the first quarter of 2016.
