Introduction:

The rules applicable to the European Globalisation Adjustment Fund (EGF) are laid down in Regulation (EU) No 1309/2013 of the European Parliament and of the Council of 17 December 2013 on the European Globalisation Adjustment Fund (2014-2020) and repealing Regulation (EC) No 1927/2006 (the 'EGF Regulation'). This Regulation covers applications for the mobilisation of the EGF submitted to the Commission after 1 January 2014.

Point 13 of the Interinstitutional Agreement of 2 December 2013 between the European Parliament, the Council and the Commission on budgetary discipline and sound financial management sets the budgetary provisions related to the EGF.

d) Detailed grounds for the transfer

In the proposal for Decision COM(2015) 555, the Commission concluded that the conditions for a financial contribution from the EGF to application EGF/2015/006 IE/PWA International, submitted by the Irish authorities, are met.

The amount of EUR 442 293 requested by the Irish authorities will contribute to the costs of a coordinated package of eligible personalised services for 108 targeted beneficiaries following redundancies in PWA International Ltd. operating in the sector of aircraft repair and maintenance and one of its suppliers, with the aim of providing assistance for reintegrating the affected persons into the labour market. In accordance with article 6.2 of the EGF regulation, the personalised services will also be provided to 108 targeted young persons not in employment, education or training (NEETs).

The redundancies were caused by major structural changes in world trade patterns due to globalisation.
