1. EXECUTIVE SUMMARY

Political dialogue continues over the Republika Srpska National Assembly session on 13 April which adopted Conclusions challenging the authorities of the High Representative, and which also included a referendum measure.

In early April HoM presented the 11th Six Monthly Report to the Political and Security Committee (PSC).

ICITAP and EUPM assisted SIPA in organizing a media event to mark the launch of the Joint Terrorism Task Force (JTTF) at the headquarters of SIPA.

In mid April a daily newspaper of the Republika Srpska (RS Nezavisne Novine) published approximately 2,000 telephone and IMEI (International Mobile Equipment Identity) numbers over a 6 day period that had allegedly been subject to interception by both SIPA and OSA (BiH Intelligence and Security Service).

EUPM Border Police members paid a two-day visit to the EU Rule of Law Mission (EULEX) in Kosovo.

BiH LEAs continued the fight against drug related crimes and arrested one person on suspicion of major money laundering Banja Luka and Bijeljina.

A bank robbery was carried out in Banja Luka when 1.033.000 KM (approx. 528.164 Euros) was stolen

Canton 8 Prosecutor's Office raised an indictment against a suspect for the murder of Vedran Puljic on 4 October 2009 during riots between different football fan groups in Siroki Brijeg.

An officer from Tomislavgrad Police Station, in a local coffee bar shot a man who was later identified as the Vice President of the Croat political party HSS-NHI BiH.

On 26 April, the Organizational Board (OB) for the 16th Srebrenica Commemoration held its constitutive session in Potočari.

The Law on Police Officials Consultation process 3rd and 4th workshops took place during 6–8 April and 27–29 April 2011 accordingly.

2. COMMENTS BY HOM

The political agenda continued to dominate the attention of the International Community and the media throughout the month of April. The Republika Srpska National Assembly session on 13 April adopted Conclusions challenging the authorities of the High Representative, and also included a referendum measure. The crisis continues at the Federation BiH level with the two HDZ parties holding a Croat National Congress in mid April which expressed dissatisfaction with the position of Croats in the FBiH government but was not as hard hitting as expected.

Within this current political climate it is more important than ever for the mission to continue technical dialogue. The mission is also focused on monitoring the security and operational planning of public events as the season of commemorations begins leading to the 16th Srebrenica Commemoration in early July.

In early April, I presented the 11th Six Monthly Report to the Political and Security Committee (PSC) and a week later I attended the CivCom discussion on the SMR and the orientation debate on the Strategic Review. I also attended the CSDP Heads of Missions meetings in Brussels at the end of March.

On 7 April, ICITAP and EUPM assisted SIPA in organizing a media event to mark the launch of the Joint Terrorism Task Force (JTTF) at the headquarters of SIPA. This important launch was well attended by law enforcement directors, chief prosecutors and key international figures and the media. Following speeches by the Director of SIPA, the BiH Minister of Security, the BiH Chief Prosecutor, the US Ambassador and the German Ambassador, there was an in depth question and answer session. The establishment of the JTTF is a direct consequence of studying related models in the US and Germany during the study trips that were organized by ICITAP and EUPM.

Adding to the already fragile political situation, in late April a daily newspaper of the Republika Srpska (RS Nezavisne Novine) published approximately 2,000 telephone and IMEI (International Mobile Equipment Identity) numbers over a 6 day period, that had allegedly been subject to interception by both SIPA and OSA (BiH Intelligence and Security Service). Through media interviews on the issue I made it clear that the mission supports a quick and thorough investigation into all aspects and circumstances surrounding the publication of these numbers to ensure that the Rule of Law has been, and continues to be, respected. The mission closely monitored the issue and met with relevant counterparts emphasising how crucial it is that police investigations or people's personal safety must not been jeopardized. I carried this message to meetings with the director OSA, the RS Director of Police Mr. Vasic, the newly appointed Chief of CID Mr. Mandic and the Minister of Interior Mr. Cadjo.

Continuing to maintain open dialogue with counterparts, on 29 April I had an open and constructive meeting with the Minister of Interior of the BiH Federation.

3. MISSION ACTIVITIES

'Police Cooperation Centres' meeting - EUPM Border Police and BiH Border Police Project Officer responsible for the initiative on establishing Police Cooperation Centres participated in the meeting organized by Democratic Control of Armed Forces (DCAF) on 6 April in Ljubljana (Slovenia). The meeting was chaired by DCAF PCC (Police Cooperation Convention) Secretariat and attended by representatives from Serbia, Albania and Montenegro as well as the European countries that are willing to support this project, i.e. Italy, Slovenia and Switzerland and International Organisation

for Migration (IOM) for BiH. The aim of the meeting was to discuss the most effective solutions and agree on the methods to approach the idea of forming Police Cooperation Centres as common centres. This is one of the key priorities set by the Committee of Ministers on 17 July 2008 in Vienna and it is part of the agenda of BiH Ministry of Security in related trans-border cooperation.

EUPM and EULEX Border Police met and discussed joint projects – EUPM Border Police members paid a two-day visit to the EU Rule of Law Mission (EULEX) in Kosovo to establish a dialogue between Border Police units of both missions, and to exchange and share information. Both the Directors of BiH Border Police and Kosovo Border Police welcomed the idea that EUPM and EULEX create a bridge between these two state-level Agencies. Common aspects of best practices and procedures in the area of integrated Border Management were discussed, and Border Police experts exchanged information on the current situation in trafficking of human beings from Kosovo, and smuggling of persons from Afghanistan and Maghreb countries, via BiH, towards Europe.

4. POLITICAL AND SECURITY UPDATE

The Republika Srpska National Assembly (RSNA) adopts Conclusions and referendum on the state judiciary – On 13 April, an RSNA special session adopted Conclusions on the state judiciary, imposed laws and alleged human rights violations committed by High Representatives (HRs). These included a referendum measure, with the question: "Do you support the laws imposed by the HR..., especially those pertaining to the BiH Court and BiH Prosecutor's Office, as well as their unconstitutional verification in the BiH Parliamentary Assembly?" The Conclusions challenge the authority of the HR, the State Court and Prosecutor's office, and by implication, the BiH Constitutional Court (BCC).

Croat National Congress – HDZ BiH and HDZ 1990 organized a second Croat National Congress (following the 2000 General Elections and unsuccessful coalition negotiations with SDP, HDZ went

into opposition, attempted to withdraw from institutions and held the first Croat National Congress which aimed to establish a 'Croat Self-Rule' (i.e. Third Entity). The attempt was prevented by strong IC engagement and sanctions against HDZ officials on 19 April; IC expressed discontent with the position of Croats, especially in relation to election of the Croat Presidency Member and with what they see as the illegal formation of the FBiH authorities without them. The Congress gathered 10 mostly very small Croat parties (apart from the HDZs, six of the eight parties did not participate in the General Elections). It described the FBiH Government as 'illegal, unconstitutional and unacceptable for the Croat people', although despite fears that it would reach a decision to ignore the new government, this did not materialize. Contrary to expectations and concerns that the Congress could further destabilize the fragile political situation, especially after the RSNA Special Session, it did not in the end get the desired support or have this effect.

Off-duty police officer kills local politician in Tomislavgrad (Canton 10, Livno) – During the evening of 16 April, an officer from Tomislavgrad Police Station shot a man in a local coffee bar who was later identified as the Vice President of the Croat political party HSS-NHI BiH (Croatian Peasants Party/New Croat Initiative). The officer was carrying a duty weapon although he was off-duty at the time of incident. The victim died on the way to hospital and the perpetrator fled the scene but he was found in the morning of 18 April in his home and arrested. He had cut his wrists but he was alive and taken to hospital. Immediately after learning about the incident HoM instructed staff to form a special team to closely monitor the investigation and assist the police where needed. The shooting has not had significant political ramifications, primarily because the HSS-HNI is politically insignificant outside Cantons 2, 6 and 10 (under 1% of votes at BiH and FBiH levels and 4,83% in Canton 10), also because there appears to be no ethnic component (it is a Croat on Croat killing), and because the initial 'facts' about the case, carried by the media, clearly point to events being the result of a personal argument over payment of a bill. The police also swiftly went on record to deny any political involvement, whilst the police, EUPM and HSS/NHI all quickly appealed to the media to avoid any speculation.

Srebrenica Commemoration – On 26 April, the Organizational Board (OB) for the 16th Srebrenica Commemoration held its constitutive session in Potočari. Acting Mayor of Srebrenica was appointed as the President of the OB whilst his deputies will be the BiH Minister of Security and

Tuzla's Mufti. It is expected that approximately 500 human remains will be buried this year. The President of OB made a welcomed strong and firm call to all members of the Board to refrain from politicizing and to focus exclusively on organizational issues. It is believed that the close co-operation of the President and Deputies of Board will be pivotal in implementing the successful work of the OB and pushing forward the preferred agenda. It was proposed that Mr Himzo Selimović (Director of the Directorate for Police Coordination - DPC), be appointed the Head of the Sub board for Security, a suggestion which is diverting from previous years' practices when SIPA was in charge of this particular sub board.

Law on Police Officials (LoPO) workshops continue – The Law on Police Officials Consultation process 3rd and 4th workshops took place during 6 - 8 April and 27-29 April 2011 respectively. During the workshops the first screening of the remaining chapters of the Law on Police Officials of BiH, which is used as a template, was completed. The final discussions to conclude the pending issues in previous workshops have commenced and the process is expected to be completed with a final workshop scheduled for 17 - 19 May 2011. The working material which includes conclusions and considerations of the participants will then be submitted to Heads of the Institutions who are participating in the process for their consideration and final decisions. The process has been assessed as very successful so far and beneficial to the participants.

5. MEDIA

Preparations for the EU Institutions Open Door Day underway – This year, the overarching theme of the presentation for the EU Institutions Open Door Day in early May was "Stronger, Faster, Better" BIH police. With this message, EUPM was not only promoting the latest public information campaign but also bringing to light the whole rationale behind this slogan – the improvements in the BIH police service that EUPM has contributed to in recent years. EUPM was represented at the Open Door Day in Brussels by Senior Inspector Aldina Ahmic, Spokesperson of Zenica Doboj Canton Police, who was also the face of the campaign, accompanied by Christophe Lammelin, EUPM Crime Adviser to SIPA and Monja Koluder, Mission Spokesperson.
