1. **EXECUTIVE SUMMARY**

A political crisis was averted in mid May with talks between Catherine Ashton and Republika

Srpska (RS) President Milorad Dodik regarding the RS referendum and its conclusions.

The third study trip hosted and organised by EUPM for the law enforcement directors and the BiH

State Prosecutor took place between 15 - 21 May in Warsaw, The Hague and Brussels. The

participants were subsequently invited on 31 May to debrief and discuss future coordination in the

Mission headquarters.

News of the arrest of General Ratko Maldic on 26 May and subsequent transfer to The Hague on 31

May dominated local and international media.

During May EUPM attended and participated in several conferences and workshops: 'Western

Balkan Risk Analysis Network' conference taking place in Sarajevo; EUPM hosted a one day

training session in "techniques for improvement of investigations in the field of organized crime" in

Sarajevo for 25 BiH Border Police officers; EUPM participated in a two-day workshop on

'Investigation and Confiscation of Proceeds of Crime in Organized Crime Cases - Legal Solutions

and Best Practice' in Banja Luka; and also participated in a two-day seminar dubbed "Improving

the Fight Against Corruption" in Sarajevo.

EUPM Prison and Detention Team facilitated a visit of the Finnish Prison Service legal advisors to

EUPM and the BiH prison service.

EUPM monitored the investigation of an explosion allegedly aimed at two HDZ (Croatian Democratic Union of BiH) politicians which occurred on 11 April in Zenica (Canton 4).

Within Operations Network 2011 and Tranzit aimed at drug trafficking, further quantities of marijuana, cocaine and heroin were seized. Also involving drug seizures and some weapon seizures, SIPA officers arrested two persons and searched five locations in Sarajevo.

In a coordinated operation called *Balkan/Dogma*, involving police agencies from several countries, RS MoI arrested one person and, on the same day, Croatian police arrested two suspects, citizens of BiH. All three are suspected of being part of an organized crime group involved in international drug trafficking. Also related to illegal drug trafficking SIPA officers conducted five house searches and arrested three persons in Canton 1. A further arrest was made in the Mostar region of a man who was in possession of approximately 400 grams of heroin.

The month of May witnessed a series of commemorations throughout BiH honouring victims of the war, which all passed peacefully.

An FBiH media programme reported on the BiH Chief Prosecutor Milorad Barasin's alleged connection with two known arms traders and suggested his possible involvement with other BiH ministers in recent arms exports.

EUPM in coordination with OHR and the EU Delegation sent a letter to the RS Minister of Interior, Mr. Cadjo, raising concerns regarding the RS Law on Police Officials.

2. COMMENTS BY HOM

Political tensions in early May kept the Mission focused, and sharpened the need to continue dialogue with interlocutors in order to reiterate the Mission's commitment to its technical agenda. Dialogue and analysis continued with the EU Family and the wider International Community regarding the current political crises which culminated in talks between HR Ashton and RS President Milorod Dodik on 13 May when the RS President agreed to address the issue of the RS referendum with a view to withdraw it and to review the conclusions.

On 3 May I hosted a dinner for state level agency directors, the High Representative (HR) and the director of ICITAP (International Criminal Investigation Training Assistance Programme) as an opportunity to bring this group together, to set out openly goals for the coming months, to discuss the study trip to Warsaw, The Hague and Brussels and to give an opportunity for this group to talk together and with the HR.

I attended the Hearing of the Committee for Civilian Crisis Prevention of the German Bundestag in Berlin on 9 May.

The third study trip hosted and organised by EUPM for the law enforcement directors and the BiH State Prosecutor took place between 15 – 21 May. An intensive program took the group to the European Agency for the Management of Operational Cooperation at the EU's External Borders (FRONTEX) in Warsaw, to the European Anti-Fraud Office (OLAF) in Brussels, and to the International Criminal Court, EUROJUST and the International Criminal Tribunal for the former Yugoslavia (ICTY) in The Hague.

Combined with two previous study trips for the same group in 2009 to the State of North Rhine-Westphalia, Federal Republic of Germany, and in 2010 to Berlin, this third trip consolidated the experience of the group, exposing them to solutions for multi-layered federally structured systems within the European Union. It has also become evident how important it is for this group to travel and work together outside of their usual environment.

I invited the participants of these study trips to the Mission for a working lunch on 31 May to assess and debrief the work and experience gained and to initiate a discussion on future coordination and cooperation.

All participants underlined the need to continue the joint operational activity, including better "marketing" of achievements and successes. EUPM shared an analysis that the current state of play may lead to further operational success but not to further institutional growth. It was noted and agreed that efforts needed to be undertaken to maintain cohesiveness. The Mission put the point across that a qualitative leap is necessary to develop a more strategic and systematic approach. The next meeting is tentatively scheduled to be hosted by Mirko Lujic, Director of SIPA, in early July.

During the week before the study trip in mid May the Mission closely followed allegations made in the media against BiH State Prosecutor, Milorod Barasim. All aspects of these allegations are being assessed by relevant EUPM experts. I met with Mr. Arben Murtezic, the Chief Disciplinary Council of HJPC (High Judicial Prosecutorial Council) on 25 May to further discuss this issue.

The news of the arrest on 26 May of the former Chief of Joint Staff of the RS Army, General Ratko Mladic, after 16 years evading capture and subsequent transfer to The Hague on 31 May dominated local and international media and continues to do so. EUPM closely monitored approximately 20 demonstrations organised by supporters of Mladic in BiH. All demonstrations ended without significant incidents and were properly policed.

On 30 May I sent a letter to the RS Minister of Interior, Stanislav Cadjo, with the support of OHR and the EU Delegation, regarding amendments to the Law on Police Officials of the RS which were sent to parliamentary procedure, as the amendments appear to contradict the principal of existing laws on police officials in BiH which should be based on the need to establish professional and reliable police organisations that are transparent and accountable. EUPM will closely monitor the further development.

3. MISSION ACTIVITIES

Western Balkan Risk Analysis Network conference in Sarajevo

On 11 and 12 May, EUPM Border Police attended the 'Western Balkan Risk Analysis Network' conference in Sarajevo. The conference was hosted by FRONTEX, the EU agency responsible for border security, with the aim to share and gather information in the field of border security and border management in the region. The conference gathered representatives of the EU delegation to BiH, Border Police agencies of all Balkans countries, as well as international organizations, including EUPM and EULEX. While discussing migrations, the participants confirmed that BiH is being used as a "transit country" for entering illegally in to EU member states. Additionally, all participants agreed that there is a recent phenomenon of illegal migrants from new countries and

regions – Afghanistan, Middle East and North Africa – which has to be analysed carefully and in a strict cooperation with all international organisations, in order to avoid serious problems for the region in the upcoming months. In relation to this, EUPM has started working on a multi-language handbook which will be used by the BiH Border Police during border checks, interviews, risk analysis, and first aid.

EUPM hosted training for BiH Border Police

On 31 May, EUPM organized, hosted and funded a one day training session in "techniques for improvement of investigations in the field of organized crime" in Sarajevo for 25 BiH Border Police officers. The aim of the training was to improve the investigations of organised crime cases and train BiH Border Police officers to undertake proper measures which would help them to develop investigations, gather proper facts also using international channels such as Interpol, international databases and cooperation with neighbouring countries. The training included a theoretical part as well as practical interviewing skills for middle-management investigative officers from all 21 BiH Border Police units and Central Investigations Office. It also tackled the fight against cross border trafficking as one of the main aspects of organized crime in the region, and the process of identifying possible members of criminal groups and illegal immigrants through examining their behaviour, the vehicles they use, and fingerprinting.

Workshop in Banja Luka hosted by RSMoI - EUPM DHoM gave the closing remarks at a two-day workshop hosted by the Republika Srpska Ministry of Interior (RS MoI) with the assistance of the Technical Assistance Information Exchange Instrument (TAIEX) on 'Investigation and Confiscation of Proceeds of Crime in Organized Crime Cases - Legal Solutions and Best Practice' on 24 and 25 May in Banja Luka. Experts in this field from Italy and Serbia also participated in the workshop. The RS Minister of Interior, Mr. Stanislav Cadjo, commented that this workshop is of big significance to the RS, as it represents a nucleus of the future cooperation between security sector institutions of BiH in the fight against organised crime.

Improving the Fight Against Corruption

A two-day seminar dubbed "Improving the Fight Against Corruption" started on 4 May at the Police Academy in Sarajevo, as a follow up to the workshop held in November 2010. The seminar

that was organized by the BiH Federation Ministry of Interior with the support of EUPM and TAIEX, was designed for police officers, prosecutors and judges at state, entity and cantonal levels, and focused on specific examples of corruption cases and case studies from the experience of the Belgian federal police. EUPM's DHoM and the BiH Federation Minister of Interior gave the opening remarks.

Prison and Detention Team

Between 3 and 5 May, EUPM Prison and Detention Team facilitated a visit of the Finnish Prison Service legal advisors to EUPM and the BiH prison service. The agenda included meeting with the representatives of the FBiH Ministry of Justice and visit to Zenica prison.

On 18 and 19 May, Federation BiH Parliament's House of Representatives passed amendments and addendums to the FBiH Criminal Code and FBiH Law on Execution of Criminal Sanctions, Detention and other Measures, offering a solution to the issue of scarce prison and correctional institution capacities in FBiH. Namely, by adopting such legislation, the perpetrators of minor and less serious crimes will be allowed to serve sentences in 'house detention' while wearing electronic monitoring devices. This system partly solves the issue of overcrowded prisons and enables accurate monitoring and supervision of prisoners. Additionally this solution is cost effective and overcomes the shortage of staff in correctional facilities. FBiH Minister of Justice said the Federation will provide funds for the introduction of this type of sentence.

4. POLITICAL AND SECURITY UPDATE

Last month's political crisis resulting from the RS National Assembly (RSNA) Conclusions and referendum decision lessened following an EU brokered agreement between the EU High Representative for Foreign Affairs and Security Policy, Catherine Ashton and RS President Milorad Dodik on 13 May. This called for the referendum's withdrawal and revision of the RSNA (National Assembly) Conclusions. In response the EU offered to bring forward a structured dialogue on the justice sector in BiH. At its session of 31 May the RSNA revoked the referendum, but failed to take similar action in relation to the Conclusions. While the crisis appears to have abated in the short term, Federation interlocutors and some in the IC will not be happy with the outcome. On a positive note the events marked a high level EU political re-engagement in BiH. This was quickly followed by the appointment of a Head for the EU Delegation.

Arrest of Ratko Mladic

On 26 May Serbian President Boris Tadic announced the arrest of former Chief of Joint Staff of the RS Army, General Ratko Mladic, who was transferred to The Hague on 31 May. Reactions from all sides in BiH followed expected political/ethnic lines. A number of protest rallies were organised, throughout the RS, but passed calmly without incident.

Commemorations

The month of May witnessed a series of commemorations throughout BiH honouring victims of the war. On 3 May, approximately 150 persons attended the commemoration for the victims of the events in former Dobrovoljacka Street in Sarajevo, which took place on 2 and 3 May 1992. Although this event was characterized as a sensitive, no incidents were reported, and the commemoration passed peacefully.

In Bratunac, sixteen remains were laid to rest at the funeral that culminated the commemorative acts for Bosniak civilian victims of the war.

In the Brcko District (BD) commemorative events included a visit to the infamous Luka Detention Center.

On 9 May, the Association of Camp Prisoners and War Prisoners (Bosniaks) in BiH organized commemorations in the villages Kozarac and Omarska, Prijedor municipality (Republika Srpska), where there were concentration camps organized for the population of Bosniak nationality during the war 1992-1995. Both commemorations were monitored by EUPM and no incidents reported. The commemoration in Omarska was attended by two members of the BiH Presidency, Mr. Zeljko Komsic and Mr. Bakir Izetbegovic.

Tuzla celebrated Liberation Day on 15 May on the same day that mourners gathered in the morning to commemorate the withdrawal of the JNA (Jugoslavian National Army) and killing of military personnel during that withdrawal in what is known as the Tuzla Column.

On 25 May, Tuzla commemorated the over 71 killed and approx. 250 injured during the Kapija attack of 1995 by RS Army forces on the city centre.

Media allegations against the BiH State Prosecutor

Throughout the month FBiH media, primarily (SDP supporting) FTV '60 Minutes' programme reported on the BiH Chief Prosecutor Milorad Barasin's alleged connection with two known arms traders and suggested his possible involvement with other BiH ministers in recent arms exports alleged to have ended up in countries on various black lists. Further, it aired video footage of Mr Barasin meeting with both traders after he had earlier denied such a meeting and stated that he would resign if proven different. Other footage showed Barasin losing his temper when confronted with this by a '60 Minutes' journalist and evading answering questions over whether he had recently purchased a property. The Disciplinary Prosecutor of High Judicial and Prosecutorial Council (HJPC) has opened a disciplinary investigation against Barasin.

Republika Srpska Law on Police Officials (RS LoPO)

Amendments to the RS LoPO were accepted by the RS government and sent to the Assembly for further procedure. The Law was scheduled on the agenda of the RSNA of 31 May. According to EUPM findings some of the proposed amendments appear to contradict the principal of existing laws on police officials in BiH as promoted by EUPM and OHR. Consequently, EUPM in coordination with OHR and the EU Delegation sent a letter on 30 May to the RS Minister of Interior, Mr. Cadjo, raising concerns on specific provisions and inviting the Minister to consider the findings of the LoPO working group when drafting amendments to the RS LoPO.

5. MEDIA

Press RS Feature Article on Corruption

In the article dubbed "Which are the most corrupted professions?" published on 30 May, the daily, Press RS, takes the latest BiH Transparency International research, alleging that doctors, judges, court officials, and the education sector are the most corrupted public institutions as a departure point and addressed the issue of 'habit' of the BIH citizens to offer a bribe. EUPM HoM was quoted as saying that everybody can actively participate in the fight against corruption. "Do not offer a bribe, do not accept corruption in your daily life, report cases to the police and provide evidence. Look for alternatives if you are in urgent need of a service. Do not give in too early, believing that you are left with no alternative but to pay a bribe. Spread word about good practice and positive behavior. Corruption lives from preserving its status and the dependency of citizens from it".
