Dear Jacob Thomsen,

Thank you for your letter of 13 December 2013.

The Council claims that the requested list of documents "does not exist".

I wish to lodge a confirmatory application (under Article 7).

I would remind the Council of the European Ombudsman's Decision in complaint 917/2000/GG, that while there was no general right of access to the content of documents there was a right for the provision of a list of documents.

The Decision included the findings that:

"On the basis of these considerations, the Ombudsman concluded that the Council's failure to maintain a list or register of all the documents put before the Council also constituted maladministration... " (para 2.7)

"The Ombudsman acknowledges that including all the documents that are put before the Council in a list or register that is accessible to citizens will entail additional administrative work. He continues to believe, however, that this ought to be accepted in view of the fundamental importance which the right of citizens to have access to

documents held by the Council has in order to guarantee openness and transparency in the latter's decision-making." (Recommendations)

After this finding the Council has, on a number of occasions, provided us with lists of documents.

I would further observe that last year the Council supplied us with a "list" of "EU classified Information handled by the Council between 2001-2011" (dated 20 August 2012). This document gave precise figures for the number of "Restricted" documents handled by the Council for each year (eg: 7,051 in 2011). If the Council knows exactly how many "Restricted" documents its handles each year it is hard to believe it cannot produce a list of them as requested in the application.
