#### d) Detailed grounds for the transfer

The unstable political environment in 2015 in priority countries led to the cancellation or postponement of several electoral processes (Philippines - Mindanao, Palestine, Libya and Afghanistan). As a result, the planned missions there had to be cancelled or postponed too. Furthermore, unfavourable political developments in Burundi forced the EU to rearrange its priorities since the necessary political conditions for a transparent electoral process were no longer met. The limited timeframe left until the end of the year does not allow for the preparation and deployment of non-programmed missions.

Therefore, an amount of EUR 2.1 million in payment appropriations can be made available for redeployment.

# d) Detailed grounds for the transfer

Changes in the regulatory basis resulted in funding agreements with some international organisations being signed very late in 2015 or postponed to 2016, thereby reducing the need for pre-financing in 2015. In addition, on the on-going trade negotiations it is difficult to predict when exactly negotiation rounds will be organised and/or related studies (such as sustainability impact assessments) need to be launched. The implementation of the Better Regulation Package has also entailed some delays which could not be anticipated at the time of the drafting of the 2015 budget.

Therefore, an amount of EUR 2.4 million in payment appropriations can be made available for redeployment.

# d) Detailed grounds for the transfer

According to article 9 of the Multiannual Financial Framework the Emergency Aid Reserve is intended to allow for a rapid response to specific aid requirements of third countries following events which could not be foreseen when the budget was established; first and foremost for humanitarian operations, but also for civil crisis management and protection, and situations of particular pressure resulting from migratory flows at the Union's external borders, where circumstances so require.

# d) Detailed grounds for the transfer

As of 26 November 2015 the overall implementation rate for the humanitarian aid chapter stood at 98% for commitment appropriations and at 84 % for payment appropriations.

The initial amount of the Operational Reserve was set at EUR 176 million but at this point only EUR 18 million in commitment appropriations remains available. However, an amount of EUR 13 million is currently being processed to cope with emergencies in, amongst others, Yemen, Boko Haram affected countries, and in countries of Latin America/Caribbean region affected by the El Niño phenomenon, which are not eligible for funding from the European Development Fund. The remaining balance of EUR 5 million is planned to be used for other critical situations, such as in the region of the Great Lakes.

The situation in South Sudan continues to deteriorate. Against a nationwide crisis of food insecurity, the latest Integrated Phase Classification (IPC) results now indicate that food insecurity is spreading and deepening, including in locations previously considered as stable. According to these results, 3.1 million people are in crisis and 830 000 people are in emergency phase of food insecurity, while 30 000 people are considered to be in a catastrophe phase requiring urgent humanitarian assistance.

This is the first time that people are identified in a catastrophe phase of food insecurity in Africa since the Somalia's famine in 2011-2012. There is, therefore, a concrete risk of famine occurring between now and December 2015 if urgent humanitarian assistance is not provided.

In addition, a measles outbreak, caused by inadequacies of the routine vaccination system, has been declared with cases in all 10 but one state of the country.

Additional EU humanitarian assistance in the amount of EUR 20 million in commitment appropriations and EUR 18.4 million in payment appropriations is needed mainly for food assistance and basic emergency services including health and nutrition.

# Why the additional funding is needed?

Additional funding is needed to urgently respond to growing humanitarian needs resulting from the deteriorating situation in terms of food insecurity, malnutrition and epidemic outbreaks.

Against a nationwide crisis of **food insecurity**, the October 2015 Integrated Phase Classification (IPC) results indicate that food insecurity is spreading and deepening, including in locations previously considered stable. 3.1 million people are in crisis (IPC Phase 3) and 830 000 in emergency (IPC Phase 4) food insecurity phase. Of extreme concern are 30 000 people estimated to be in catastrophe (IPC Phase 5) phase requiring urgent humanitarian assistance. This is the first time people are identified in the IPC 5 phase in Africa since the Somalia famine of 2011-2012. There is a concrete risk of famine occurring between now and December 2015 if urgent humanitarian access and assistance is not provided in the most affected areas, in particular in southern Unity State. The most affected populations are the Internally Displaced Persons (IDPs) who are dispersed and the host communities affected by the ongoing conflict.

The overall **nutrition situation** remains critical with Global Acute Malnutrition (GAM) prevalence above the emergency threshold (GAM >15%) in the conflict affected states and in other areas.

At the same time, a **measles outbreak** has been declared in parts of the country. All 10 States but one (Northern Bahr el Gazal) are reporting cases (total of 460). Because of the inadequacies of the routine countrywide vaccination system measles cases are increasing in many areas, in a lethal combination with the high levels of malnutrition.

A malaria outbreak was declared in August 2015. It has affected five states, with more than 1.8 million cases confirmed countrywide, 634 deaths and malaria accounting for 43% of total consultations. On average, more than 37 000 new malaria cases are reported every week. Emergency procurement of malaria drugs, rapid diagnostic tests and mosquito nets is underway. Malaria accounts for 17% of all deaths recorded at IDP sites.

The 2015 South Sudan Humanitarian Response Plan, which was revised in June 2015 to USD 1.63 billion, is currently 58% funded. The funding gap amounts to USD 684 million. The 2015 appeal of the International Committee of the Red Cross for an amount of EUR 150 million also has a funding gap of EUR 30 million.

# What will be the increase used for?

The main axes of response will be food assistance, basic emergency services including health and nutrition.
