Subject: 2016 SISNET Draft Budget (VISION)

1. The Financial Regulation as established by Council Decision 2000/265/EC of 27 March 2000 on the establishment of a financial regulation governing the budgetary aspects of the management by the Deputy Secretary-General of the Council, of contracts concluded in his name, on behalf of certain Member States, relating to the installation and the functioning of the communication infrastructure for the Schengen environment, 'SISNET'¹, as subsequently amended, provides in its Article 8 that the Member States referred to in Article 25 of that Financial Regulation, meeting within the Council, shall adopt the budget, once the Working Party for Schengen Matters (SIS/SIRENE) has delivered its opinion on the preliminary draft budget.
2. At its meeting on 27 November 2015, the Working Party for Schengen Matters (SIS/SIRENE) delivered a favourable opinion on the preliminary draft budget, as set out in document 13849/15 SIRIS 78 VISA 350 COMIX 557.

3. Taking into consideration the discontinuation and dismantling of VISION in 2016, the 2016 SISNET draft budget foresees a derogation to Article 10 of the referred Financial Regulation, as there would be no need for an amending budget in 2016. For the same reason, it also foresees a derogation to the invoicing schedule, provided for in Article 28(1) of the referred Financial Regulation, for the contributions of the concerned Member States and Iceland, Norway, Switzerland and Liechtenstein.
4. On this basis, COREPER is invited to submit the budget for SISNET, as set out in the Annex, for adoption by the Member States referred to in Article 25 of the abovementioned Financial Regulation.
5. The Secretary-General shall notify the decision to adopt the budget to the States referred to in Article 25 of the above-mentioned Financial Regulation.
