Dear colleagues,

Please find below the DAA for next week's COAFR meeting:

1. **Zimbabwe**

The Group will have a first exchange of views on the outcome of the ZANU-PF congress on the basis of an EEAS presentation and will continue discussions on the review of EU restrictive measures on the basis of an EEAS options note (MD 085/15), with a view to agreeing a way forward.

2. **Sudan**

The Group will discuss the situation in Sudan, on the basis of a HoMs report (EAS/1070/15) on Darfur and will have an exchange of views on the Addis peace talks and on cooperation in the field of migration on the basis of an EEAS presentation.

3. **Eritrea**

The Group will have an exchange of views on the EU's engagement with Eritrea, on the basis of a HoMs report on the last meeting with members of the Government of Eritrea on 26 November 2015 (EAS/1110/2015).

4. **Djibouti**

The Group will have an exchange of views on the situation in Djibouti, in particular on the evolution of the negotiations between the Government of Djibouti and the coalition of opposition parties on the implementation of the Framework Agreement on political reforms, on the basis of a HoMs report (to be circulated).

5. **Swaziland**

The Group will discuss the political, security and economic situation in the country on the basis of a HoMs report on the last art. 8 dialogue meeting (EAS/1145/15).

6. **Lesotho**

The Group will discuss the political, security and economic situation in the country on the basis of a HoD report on the last art. 8 dialogue meeting (EAS/1146/15).

7. **The Gambia**

The Group will have an exchange of views on the latest developments in the country on the basis of an EEAS presentation and will be informed of next steps following the departure of the EU's Charg? d'Affaires.
