## **1. UNFCCC Secretariat template filled in for the European Union**

### **I. Introduction**

1. This Staff Working Document accompanying the Report on the additional period for fulfilling commitments under the Kyoto Protocol, submitted by the European Union, contains the information required to be reported upon the expiration of the additional period for fulfilling the commitments for the first commitment period of the Kyoto Protocol (hereinafter referred to as the true-up period),<sup>1</sup> in accordance with the relevant decisions of the Conference of the Parties serving as the meeting of the Parties to the Kyoto Protocol.<sup>2</sup>
2. The information contained in this Staff Working Document covers the period 1 January to 18 November 2015, as well as the period 1 January to 31 December 2014, in accordance with decision 15/CMP.1, annex, paragraph 20.
3. The information required to be included in the report is presented using the standard electronic format (SEF) tables in accordance with decision 3/CMP.10, paragraph 3.
4. In addition to the SEF tables, the information required to be included in the report in accordance with decision 15/CMP.1, annex, paragraphs 12–16 is presented in reports R2–R5.<sup>3</sup>

### **II. Information provided before the submission of the report**

5. The SEF tables of the European Union (with the file name euc-2015-sef-cp1-24jul.zip ) covering the period 1 January to 31 December 2014 have been submitted previously and can be found in the UNFCCC website at [http://unfccc.int/files/national\\_reports/annex\\_i\\_ghg\\_inventories/national\\_inventories\\_submissions/application/zip/euc-2015-sef-cp1-24jul.zip](http://unfccc.int/files/national_reports/annex_i_ghg_inventories/national_inventories_submissions/application/zip/euc-2015-sef-cp1-24jul.zip).
6. The reports R2–R5 of Party covering the period 1 January to 31 December 2014 have not been submitted because there was nothing to report for this period.

### **III. Information incorporated into the report**

7. The SEF tables of European Union (with the file name RREG1\_EU\_2015.xlsx) covering the period 1 January to 18 November 2015 are part of this report.
8. For the reports R2–R5 of European Union covering the period 1 January to 18 November 2015 there is nothing to report, and for this reason they are not included.

9. In addition to the information presented in sections II and III above, the European Union also reports the following information:
- a) **Information on actions to correct discrepancies, changes to the national registry to prevent discrepancies from reoccurring and resolution of previous questions of implementation pertaining to transactions**
10. *Option A.* In accordance with paragraph 17 of the annex to decision 15/CMP.1, the European Union reports that no discrepancies have been identified by the international transaction log during the period 1 January to 18 November 2015 or the period 1 January to 31 December 2014; therefore, there was no need to take any action or make any change to its registry with regard to this issue.
11. *Option A.* In accordance with paragraph 17 of the annex to decision 15/CMP.1, the European Union reports that no questions of implementation pertaining to its transactions have been previously identified.
- b) **Commitment period reserve**
12. The commitment period reserve (CPR) of the European Union is 17,659,243,358 t CO<sub>2</sub> eq. The calculation of the European Union's CPR is contained in chapter G.2 of the "Report on the individual review of the annual submission of the European Union submitted in 2014"<sup>4</sup> and was agreed by the relevant expert review team.
- c) **Total quantity of units in the retirement accounts**
13. Table 1 presents the total quantity of Kyoto Protocol units in the European Union's retirement account at the end of the true-up period, in accordance with paragraph 49(b) of the annex to decision 13/CMP.1.

The EU and its Member States fulfil their commitments under Article 3(1) of the Kyoto Protocol jointly, in accordance with the provisions of Article 4 thereof. At the time of ratification, the following 15 countries were Member States: Austria, Belgium, Denmark, Germany, Greece, Finland, France, Ireland, Italy, Luxembourg, the Netherlands, Portugal, Spain, Sweden and the United Kingdom. The quantity of units retired for the EU, and showed in Table 1 above, is calculated as the sum of the quantity of units in the 15 Member States retirement accounts.
