1. The Commission submitted to the Council a proposal for a Decision of the European Parliament and of the Council on the mobilisation of the European Globalisation Adjustment Fund (EGF), as recorded in document 15096/13 FIN 665 SOC 842, accompanied by the corresponding proposal for transfer of appropriations No DEC 31/2013 of the general budget for 2013, as recorded in document 15087/13 FIN 659.

The proposal aims at mobilising an amount of EUR 9 810 000 under the EGF to meet an application from Finland to deploy the Fund in connection with 4 509 redundancies in Nokia plc, Nokia Siemens networks and its 30 subcontractors. Delocalisation of production and assembly operations to Asia lead the company to reduce its investments and its staff in Europe, in a context of major structural changes in the world trade patterns due to globalisation.

The purpose of the proposed transfer is to move an amount of EUR 9 810 000 in commitment appropriations from Article 40 02 43 (*Reserve for the European Globalisation Adjustment Fund*) to Article 04 05 01 (*European Globalisation Adjustment Fund*).

- 3. At the simplified trilogue procedure provided for in Point 28 of the Interinstitutional Agreement of 17 May 2006, an agreement was reached on the mobilisation of the EGF and on the amount proposed by the Commission.
- 4. The <u>Budget Committee</u> examined both proposals at its meeting on 29 October 2013.
- 5. Following that examination, the <u>Budget Committee</u> agreed, by a qualified majority to suggest that the Permanent Representatives Committee advise the Council to:
 - adopt the Decision on the mobilisation of the EGF;
 - approve the proposed transfer of appropriations;
 - approve the draft letter in the ANNEX to that effect.
