# RESTREINT UE

### Page 18, point 3.1.8, third paragraph, first sentence should be deleted.:

"In the case of mutual legal assistance in criminal matters, when there is no Treaty or a Treaty does not allow contact on a regional level, BIRS is the central authority to which the request of mutual legal assistance has to be sent."

## Page 20, point 4.1.1, first line:

Instead of: "The number of requests sent and replies receives by ..."

it should read: "The number of requests sent and replies *received* by ..."
