– State of play

The Council took note of the information provided by the Presidency on the state of play on the CAP reform, particularly as regards the outcome of the informal trilogue held on 17 September 2013, as well as of the comments made by delegations and by the Commission representative.

The Council further reached agreement on the final adjustments to the Council negotiating mandate set out in docs. 13938/13 + COR 1 and 13959/13, with a view to allowing the Presidency to conclude CAP reform negotiations with the European Parliament at the next informal trilogue. The Council noted that CZ, IT, HU, PL and SE could not support these adjustments.
