A number of delegations opposed the solutions found by the negotiators, in particular in relation to the EP amendments to Annexes I and II, and expressed major difficulties with other parts of the text. Following a short exchange of views, the Chair of the Committee concluded that he would inform the EP of the Council's position.

The Committee discussed the only remaining obstacle in connection to the AMF Regulation and supported (after a silence procedure held the same day) the CLS position recommending not to use Article 80 as a legal base. The Presidency will inform the Rapporteur accordingly while suggesting possible alternative formulations in the spirit of the consensus at the Committee.

#### 101. Follow-up to the Council meeting (Justice and Home Affairs) on 5/6 December 2013

The Committee was informed about the main items discussed at the Council, while also HU and SK emphasised the discussion on EPPO.

The Committee supported the following intervention of the Legal Service on the organisation of discussions in the Council and the participation of members of the College.

"The representative of the Council Legal Service explained that the intervention by the Commission Legal Service, at the invitation of the Commissioner, during the debate in Council was inappropriate and not in line with the Council Rules of procedure. The Legal Service of the Council assists the Council and its preparatory bodies in order to ensure that Council acts are lawful and well drafted. When doing so, it acts with the necessary independence, objectivity and impartiality. It is not questioned that members of the Council and/or other institutions, including the Commission, may have divergent views to those expressed by the Council Legal Service and nothing prevents them from conveying their views. However, each institution has its own legal service to advise its decision-making instances, under the conditions of impartiality and loyalty to their institution. It is obvious that the Commission Legal Service could not in full impartiality question within the Council the legality of a proposal adopted by the Commission, regardless the view it has taken internally. This is the reason why it is not for the Council Legal Service to advise the Commission or the European Parliament on how these institutions should act and why it should not be for the Commission Legal Service to advise the Council. Furthermore, a verbal confrontation of the representatives of the Legal Services will most often not facilitate a better assessment of the legal questions by the members of the Council, while it will prevent that the opinions of the Council Legal Service be presented in the required independent, non-partisan approach."

## **102. Follow-up to the Council meeting (Foreign Affairs/Trade) on 3 December 2013**

The Chair recalled the main results of the 9th WTO Ministerial Conference (MC9) and the outcome of the Council meeting held in the margins of the MC9.

Following the discussion, the Chair agreed with the appropriateness of reflecting the positive MC9 outcome in the conclusions of the forthcoming European Council and clarified the procedural aspects concerning the adoption of *Council Decision establishing the position to be taken by the European Union within the 9th Ministerial Conference of the World Trade Organization regarding food security, Tariff Rate Quota administration and the Monitoring Mechanism* (doc. 15637/13) by the Council (Justice and Home Affairs) on 6 December 2013.

**103. Proposal for Decision of the European Parliament and of the Council on granting an EU guarantee to the European Investment Bank against losses under financing operations supporting investment projects outside the Union (First reading)**

The Committee agrees that the reference to "amounts exceeding EUR 110 million which have been paid back to the fiduciary account established for the FEMIP" refers to past reflows and does not prejudge the use of future reflows to be paid back to the fiduciary account established for the FEMIP from 1 January 2014.

**104. Follow-up to the Council meeting (Economic and Financial Affairs) on 10 December 2013**

- The Ministers' breakfast session focused on the Eurogroup debrief of the previous day and 22 November 2013, as well as on the economic situation.
- The formal Council session started with the discussion on taxation of savings income. ECOFIN did not reach political agreement on the item. The state of play of this item will be noted in the ECOFIN report to the EC on tax issues accordingly, as this question was on the December ECOFIN agenda in view of the EC mandate to reach a political agreement on the issue by the end of 2013.
- The Ministers then addressed the outstanding issues from the Council's perspective on the Bank Recovery and Resolution and Deposit Guarantee Schemes directives. The agreed updated negotiating stance on these issues will be used by the Presidency at the final trilogue with the European Parliament on 11 December 2013.

- As the next point on the agenda, the Ministers had an exchange of views on the state of play of a proposal for a Council Regulation establishing a facility for providing financial assistance for Member States whose currency is not the euro. The dossier will be examined further with a view to securing the unanimous agreement that is required for this proposal.
- Under the non-legislative items part, the Council discussed the Alert Mechanism Report and 2014 Annual Growth Survey. They were also briefed on the EFC report on the coordination of economic policies and reforms and the pilot project on ex-ante economic reform plans carried out by the EPC. The ECOFIN President will write a letter to the President of the European Council on the main areas of economic policies and reforms.
- The Ministers also adopted Council opinions on the Economic Partnership Programmes of Spain, France, Malta, the Netherlands and Slovenia. In addition, the Council adopted a decision and recommendation to Poland in relation to its excessive deficit, and the Commission briefed on broader assessment of effective action and other EDP related aspects from its Autumn round of assessment.
