COMMENTS ACCOMPANYING THE COUNCIL RECOMMENDATION ON THE DISCHARGE TO BE GIVEN TO THE EXECUTIVE AGENCY

The <u>Council</u> welcomes the Court's opinion that, in all material respects, the Executive Agency's annual accounts present fairly its financial position as at 31 December 2014 and the results of its operations and its cash flows for the year then ended, in accordance with the provisions of the Executive Agency's Financial Regulation, and that the underlying transactions for 2014 are legal and regular in all material respects. Nevertheless, some observations need to be made.

The Council notes with concern that at the end of 2013 the budgetary needs of the Executive Agency were overestimated and that a large part of the appropriations carried over from 2013 were cancelled in 2014. The Council, therefore, urges the Executive Agency to improve its financial programming.

Although the Executive Agency's initial budget was reduced in September 2014, the Council regrets that the Court detected a low implementation rate and high level of carry-overs and, while acknowledging that 2014 was a transitional year, the Council encourages the Executive Agency to improve its monitoring of the budget implementation, in order to reduce the level of commitments carried over to the next financial year to the strict minimum, in line with the budgetary principle of annuality.

Nevertheless, one observation needs to be made.

The Council regrets that the Court found weaknesses in the Executive Agency's asset management and urges the Executive Agency to take appropriate action with a view to keeping the Assets Register up to date, formalising the inventory procedures and providing sufficiently detailed information in the Executive Agency's guidelines on the capitalisation of internally developed intangible assets to ensure that a consistent approach is used.
