The Committee agreed on the mandate of the Ad Hoc Working Party on the Strengthening of the Banking Union, thus allowing for its establishment.

Statement by Germany

"Germany welcomes the establishment of a high-level working party to reach a common understanding on measures to reduce bank risks. However, Germany opposes the proposal of the Commission to mutualise deposit insurance. The proposal is not a suitable basis for discussion. For this reason, Germany is opposing the mandate for the establishment of a high-level working party presented by the Presidency, since it would enable negotiations on the EDIS proposal.

The European Commission proposal on EDIS sets the wrong priorities and incentives. Through the proposal, existing and future bank risks, which are still largely of a national origin, are being transferred to other Member States and their depositors – whereas the responsibility for those risks remain national.

It is now the main task to reduce risks in the banking sector across the European Union."

Joint statement by Cyprus and Denmark

"Cyprus and Denmark take note of Article 12(1) of Regulation (EC) No 713/2009 establishing an Agency for the Cooperation of Energy Regulators (ACER) which provides that the term of office of the members of the Administrative Board and their alternates shall be four years.

At the same time, they draw attention to the preferences expressed by Coreper on 2 December 2015 as regards the appointment by the Council of three members and three alternate members of the said Administrative Board, in particular as regards Mr. Georgios SHAMMAS and Mr. Martin HANSEN, who both received an equal level of support.

Mr. SHAMMAS and Mr. HANSEN have agreed to resign after fulfilling two years of their respective four-year mandates. Cyprus and the Denmark note the candidates' agreement and accordingly jointly call upon Coreper to recommend to the Council to appoint each of those persons to the position formerly held by the other one of the two within the Administrative Board of the ACER for the remaining two years of the mandates concerned. This would resolve the situation described above."
