d) Detailed grounds for the transfer

Following the signature on 16/11/2015, the agreement with Mauritania has entered under provisional application as from 16/11/2015.

Following the signature on 09/12/2015, the agreement with Liberia has entered under provisional application as from 09/12/2015.

Following the signature on 27/11/2015, the agreement with Greenland has entered under provisional application as from 01/01/2016.

In light of the above, the financial counterparts of the agreements (Mauritania: EUR 59 125 000 in commitment and payment appropriations; Liberia: EUR 650 000 in commitment and payment appropriations; and Greenland: EUR 17 799 978 in commitment appropriations and EUR 16 099 978 in payment appropriations) have to be paid. Therefore, the corresponding commitment and payment appropriations are needed on the operational budget line.
