- The <u>General Secretariat of the Council</u> has been informed by the Austrian Government of its decision to nominate Mr Eduard STAUDECKER as its member in the category of Government representatives on the CEDEFOP Governing Board, replacing Mr Reinhard NÖBAUER.
- 2. The <u>General Secretariat of the Council</u> has been informed by the Commission of the designation of Mr Michael ANTONIOU (CY) in the category of representatives of Employers' organisations, replacing Mr Michael PILIKOS.
- 3. Under Article 4 of Regulation (EEC) No 337/75, as amended by Regulation (EC) No 2051/2004, the members of the Governing Board, except for the Commission's representatives, are appointed by the Council for a period of three years.

COUNCIL DECISION

of

renewing the Governing Board of the European Centre for the Development of Vocational Training

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to Council Regulation (EEC) No 337/75 of 10 February 1975 establishing the European Centre for the Development of Vocational Training, and in particular Article 4 thereof ¹,

Having regard to the nomination submitted by the Austrian government,

Having regard to the nominee submitted to the Council by the Commission as regards the Employers' representatives,

Whereas:

- (1) By its Decisions of 14 July 2015² and of 14 September 2015³, the Council appointed the members of the Governing Board of the European Centre for the Development of Vocational Training for the period from 18 September 2015 to 17 September 2018.
- (2) A member's seat is available for Austria on the Governing Board of the Centre in the category of Government representatives as a result of the resignation of Mr Reinhard NÖBAUER.

- (3) A member's seat on the Governing Board of the Centre in the category of representatives of Employers' organisations has become vacant for Cyprus as a result of the resignation of Mr Michael PILIKOS.
- (4) The members of the Governing Board of the aforementioned Centre should be appointed for the remainder of the current term of office, which expires on 17 September 2018.
