## 3. Preparation for the Council meeting (Agriculture and Fisheries) on 14 March 2016

- a) Use of financial instruments in the agriculture sector
  - Oral presentation by the Commission

<u>The SCA</u> took note of the update provided by the Commission on the use of financial instruments in the areas of agriculture and rural development, and of the comments made by delegations.

At the forthcoming Council, the Commission and the EIB will be invited to inform Ministers about the use of financial instruments and Ministers will be invited to share their experience and to put questions to the Commission and the EIB.

<u>The SCA</u> endorsed the summary of contributions set out in document 6284/16 + COR 1 and took note of the exchange of views on the questionnaire included in the above document in preparation of the related "Agriculture and Fisheries" Council debate on 14 March 2016.

The <u>SCA</u> also took note of the positions of delegations and of the Commission's reaction, as well as of the elements thereof which, in the Presidency's view, could lead to a fair degree of convergence in Council.
