CURRICULUM VITAE

Mr Jaya Ratnam is currently Singapore's High Commissioner in Negara Brunei Darussalam since June 2012.

Born in Singapore on 28 June 1966, Mr Ratnam graduated with a Bachelor of Arts (Honours) from the National University of Singapore in 1991 and Masters in International Public Policy from Johns Hopkins University, USA in 2000.

Mr Ratnam joined the Singapore Foreign Service in June 1991. In the Ministry's Headquarters, Mr Ratnam covered several portfolios including Eastern Europe, Southeast Asia and International Organisations. He was Director of the International Economics Directorate from January 2009 to January 2011 and Director-General of the Consular Directorate from January 2011 to May 2012.

Mr Ratnam had served in Kuala Lumpur (March 1994 to September 1997) and Jakarta (January 2002 to August 2005). He also served as Deputy Permanent Representative in the Singapore Permanent Mission in Geneva from September 2005 to December 2008.
