The recast Eurodac regulation (Regulation (EU) No 603 (2013)) of 26 June this year stipulates that data in Eurodac shall, under certain conditions, be available for law enforcement's authorities of Member States in their fight against terrorism and serious crime. The Associated Countries are only associated with the asylum elements of the Regulation. Thus, the data availability for the fight against terrorism and serious crime does not apply for these countries, unless new Agreements with the EU are signed and concluded.

In the meeting of the Dublin Joint/Mixed Committee 12 November this year the Commission informed that exploratory talks with a view of starting formal negotiations with Associated Countries interested in taking part of the law enforcement part of the Regulation will be called for by the beginning of 2014. The Commission requested the Associated Countries to state their interest in this regard in writing before the end of the year.

Herewith, I may, on behalf of Norway, state an interest in negotiating an Agreement enabling Norwegian law enforcement authorities to make expanded use of Eurodac data. We agree that negotiations are held together for all interested Associated Countries and with Denmark.

Finally, let me remind you that Norway has signed an agreement associating us with the Prüm decisions, but that the agreement has not yet been ratified.
