### **Statement by Germany**

**"The Federal Republic of Germany supports the efforts undertaken by the Republics of Austria (ratification) and Malta (accession) to become contracting States to the Hague Convention of 1965 on the Service of Documents. However, the Federal Republic of Germany has remaining doubts as to whether the decision that the Council is being asked to adopt today is covered by exclusive external competence of the European Union. It is not clear why common rules of civil justice cooperation among Member States might be affected or altered in their scope (Article 3 para. 2 of the TFEU) by the Hague Convention on the Service of Documents becoming applicable to Austria and Malta. The Hague Convention on the Service of Documents applies in relations with third States.**

**Among the Member States of the European Union, Regulation 1393/2007 (“European Service Regulation”) clearly takes precedence over the Convention.**

**It is therefore important that the decision does not serve as a model or act as a precedent for any other measures of the European Union that aim to regulate comparable subject matters, where exclusive external competence of the European Union could play a role.”**

**"The Commission considers that the above mentioned "Union submission" to be submitted to the IMO is covered by EU exclusive competence. Submission of proposals to the IMO on issues of EU competence is an act of external representation and should be made by the Commission on behalf of the EU to IMO and should therefore be sent to the IMO by the Commission.**

**In the view of the Commission, the procedural arguments against presenting submissions to the IMO by the Commission on behalf of the EU are not convincing as there is no evidence to suggest that the IMO, as a specialized agency of the United Nations, would be in a position to reject such a submission.**

**The Commission thus maintains its position that the Treaty provisions on external representation of the Union should be applied and, consequently, to present the submission in question to the IMO by the European Commission on behalf of the European Union is the only legally correct way forward. In case of non-respect of the above rules, the Commission reserves all its rights in this regard."**

Outside these rules the Member States coordinate their negotiation positions within their competences in their own responsibility and outside the organs of the European Union. The Position of the Union is decided in the procedures of the organs of the European Union to the extent that the matter falls within the competence of the Union. In doing so the European Union and its Member States cooperate sincerely in order to possibly be able to speak with one voice. The present paper is according to our view intended to serve exclusively for the negotiations at the seventh meeting of the intergovernmental negotiating committee on the Minamata Convention (INC-7) and does not affect the distribution of substantive competences between the European Union and its Member States."**
