Statement by Germany

"The Federal Government continues not to share the Commission's view that Article 8(6) of the Return Directive requires explicit transposition into German law. Germany already has an effective forced-return monitoring system. Administrative and technical monitoring of forced returns may also be carried out by the immigration authorities, the federal and state police forces, as well as through judicial review by independent courts.

The wording of Article 8(6) was intentionally broad, and nothing within those provisions obliges Member States to establish an independent monitoring body. If that had been the intention when drafting the Directive, the text could have included such an additional provision.

As the Commission itself stated in its letter of 16 October 2014, the essential feature of forced-return monitoring arrangements is examination by third parties that are not directly involved in the return process. This applies at least to judicial review of forced returns. Moreover, Article 8(6) refers to 'forced-return monitoring', not forced-return 'observation'. Therefore, monitoring may also take place by the courts after the event, for example following an appeal.

In addition to judicial and administrative review, various non-governmental and church organisations keep a watch on removals and forced returns at key German airports on a voluntary basis. While Germany's authorities basically welcome these organisations' committed involvement in this area, there is no obligation to facilitate such activities, nor is it necessary given the existing monitoring options described above."

"The document to be adopted (6825/16) suggests that the member state holding the Presidency shall be responsible for implementing the travel restrictions for third-country nationals stipulated by the EU sanctions regime by entering individuals subject to an entry ban in the SIS pursuant to Article 26 of Regulation (EC) 1987/2006 (SIS II Regulation).

As far as we understand, this member state would remain responsible for this EU sanctions regime beyond the six-month Presidency (footnote 2 of the proposal in document 6825/16). This member state would also be responsible for any modification or removal of an alert (paragraph 2 of the Annex to document 6825/16)."

Statement by UK

"The United Kingdom wishes to record its view that the above Council Decision, being a measure proposed pursuant to Title V of Part Three of the Treaty on the Functioning of the European Union, is subject to Protocol (No. 21) to the Treaties on the position of the United Kingdom and Ireland in respect of the Area of Freedom, Security and Justice. Accordingly, the United Kingdom does not consider that it is automatically bound, as suggested by Recital (4), to participate in the Council Decision. As a result, the United Kingdom will confirm prior to formal adoption of the Council Decision whether we will exercise our right under Protocol 21 to opt in to the Council Decision."
