The Presidency intends to regularly update the SCA and Council on the market situation and organise a debate at the June "Agriculture and Fisheries" Council on support measures and possible additional funding.

The SCA took note of the concerns expressed by the French delegation (doc. 7288/16), supported by a large number of Member States, regarding the upcoming exchange of tariff offers in the context of the resumed EU-Mercosur negotiations, of delegations' comments, as well as of the Commission's reaction and call on Member States to provide their comments and proposals on these negotiations both directly to the Commission and via their Trade colleagues. The Presidency intends to keep the Mercosur negotiations under regular review by the SCA during the upcoming period.

5. Organization of future work

The Presidency informed the SCA on the next SCA meeting on 4 April as well as on the upcoming "Agriculture and Fisheries" Council meeting on 11 April 2016.
