J	- Exchange of views

Following the exchange of views on vulnerable consumers, held at the Energy Working Party on 14 January on the basis of the London Forum Guidance document on Vulnerable Consumers, delegations are invited, by **12 February** cob, to provide written comments on the guidance document including answers to the following questions:

- 1. With reference to Member States' national policies to protect consumers in vulnerable situations, could you identify the factors (indicators of energy poverty, population, disposable income spent on energy costs etc.) being essential for your definition and/or description of vulnerable consumers? Could you also indicate the proportion of the overall population vulnerable consumers represent?
- 2. Describe your national measures available to protect vulnerable consumers. Describe the proportion between any short term and long term measures.
- 3. Would delegations concur with the recommendations described in Chapter 5 of the above guidance document on vulnerable consumers?

The Presidency would also like to reiterate that some aspects on vulnerable consumers will be part of the Council conclusions on Energy prices and Competitiveness, to be adopted at the TTE (Energy) Council on 13 June 2014. The tentative timetable in annex sets out the main steps in the run up to the June Council.
