Nevertheless, some observations need to be made.

The Council regrets the weaknesses found by the Court in the Executive Agency's safeguarding of assets.

The Council regrets that, again, a high level of commitment appropriations was carried over to 2017. It calls on the Executive Agency to continue improving its financial programming and monitoring of the budget implementation, in order to reduce the level of commitments carried over to the following financial year to the minimum strictly necessary, in line with the budgetary principle of annuality.

The Council welcomes the Court's opinion that, in all material respects, the Executive Agency's annual accounts present fairly its financial position as at 31 December 2016 and the results of its operations and its cash flows for the year then ended, in accordance with the provisions of the Executive Agency's Financial Regulation, and that the underlying transactions for 2016 are legal and regular in all material respects. Nevertheless, some observations need to be made.

The Council invites the Executive Agency to consider introducing differentiated budget appropriations to reflect the multiannual nature of operations and its implementation delays. The Council regrets that, again, a high level of commitment appropriations was carried over to 2017, especially for administrative expenditure.

It calls on the Executive Agency to continue improving its financial programming and monitoring of the budget implementation, in order to reduce the level of cancellation carry-overs and to avoid an overestimation of budgetary needs.

The Council welcomes the Court's opinion that, in all material respects, the Executive Agency's annual accounts present fairly its financial position as at 31 December 2016 and the results of its operations and its cash flows for the year then ended, in accordance with the provisions of the Executive Agency's Financial Regulation, and that the underlying transactions for 2016 are legal and regular in all material respects. Nevertheless, some observations need to be made.

The Council recognises the Executive Agency's plan allowing to take corrective action in the HR management process which was initiated after an audit of the Commission's Internal Audit Service (IAS) and encourages the Executive Agency to pursue it.

Moreover, the Council emphasises the necessity to continue the Executive Agency's corrective action, resulting from its internal control system, for the management of grants within the Horizon 2020 programme.

The Council invites the Executive Agency and the Commission to improve their internal dialogue and cooperation, and their external communication, as well as specific issues in the area of IT and HR management.

The Council welcomes the Court's opinion that, in all material respects, the Executive Agency's annual accounts present fairly its financial position as at 31 December 2016 and the results of its operations and its cash flows for the year then ended, in accordance with the provisions of the Executive Agency's Financial Regulation, and that the underlying transactions for 2016 are legal and regular in all material respects. Nevertheless, some observations need to be made.

As regards the procurement and recruitment committees, the Council regrets that several weaknesses in their reports were identified by the Court. It calls on the Executive Agency to improve the reports in order to maximise the transparency of these procedures. The Council is satisfied that the agency has taken a number of strategic and operational measures to enhance the process for the recruitment and the allocation retention of its staff. The Council encourages the Executive Agency to further implement the action plan agreed in collaboration with the Commission's Internal Service (IAS).

Finally, the Council regrets that a high level of commitment appropriations was carried over to 2017. It calls on the Executive Agency to continue improving its financial programming and monitoring in relation to external audits and communication, in order to reduce the level of commitments carried over to the following financial year to the minimum strictly necessary, in line with the budgetary principle of annuality.
