	Information to national Parliaments			

- On 9 October 2017, the Commission submitted to the Council draft amending budget (DAB)
 No 6 to the general budget for 2017.
- 2. In order to allow the Council to adopt a position on DAB No 6/2017¹ without delay, the Council has to decide, considering the urgency of the matter, to shorten, in accordance with Article 3(3) of its Rules of Procedure, the eight-week period laid down in Article 4 of Protocol No 1 on the role of national Parliaments in the European Union.
- 3. National Parliaments have to be informed thereof.

The Council position on DAB No 6/2016 shall contain a recital stating that "for needs related to national Treasury management, draft amending budget No 6 to the general budget for 2017 needs to be adopted without delay. Therefore, it is justified to shorten, in accordance with Article 3(3) of the Council's Rules of Procedure, the eight-week period for the information of national Parliaments laid down in Article 4 of Protocol No 1.".

- 4. Accordingly, the <u>Permanent Representatives Committee</u> is requested to:
 - suggest that the Council:
 - decide, on the basis of Article 3(3) of its Rules of Procedure, to shorten the eight-week period for the information of national Parliaments laid down in Article 4 of Protocol No 1 on the role of national Parliaments in the European Union;
 - approve the attached communication to be addressed to national Parliaments by the General Secretariat of the Council;
 - agree, by unanimity, to use the written procedure for this purpose.
