The amount of EUR 347 000 in non-differentiated appropriations was earmarked for support expenditure for the WiFi4EU initiative on budget item 09 01 04 01, Support expenditure for CEF-ICT. The management of this initiative being delegated to the Innovation and Networks Executive Agency (INEA), the Commission requests the transfer of the corresponding support appropriations to the subsidy line of the Agency.

d) Detailed grounds for the transfer

In 2017, given the late adoption of the WiFi4EU legal base, an amount of EUR 580 000 in commitment and payment appropriations initially foreseen to cover the costs of the Agency for the launch of the WiFi4EU initiative was transferred from the Agency subsidy line to the WiFi4EU operational line 09 04 03 01 (DEC 30/2017) to be used for the first call for proposals. As the Agency is now tasked to implement the initiative, a total amount of EUR 724 123,15 in commitment and payment appropriations is necessary to cover its additional running costs, of which EUR 347 000 are covered from the CEF-ICT support line (09 01 04 01) and EUR 377 123,15 are to be returned from the WiFi4EU operational line.

d) Detailed grounds for the transfer

Regulation (EU) 2017/1953, adopted on 25 October 2017, provides for the promotion of internet connectivity in local communities (WiFi4EU) under the Connecting Europe Facility. The cost-benefit analysis shows that the delegation of the management of the initiative to the Innovation and Networks Executive Agency, which already manages parts of the Connecting Europe Facility, would contribute to achieving the objectives of this initiative more effectively. Such delegation would inter alia deliver cost savings of about EUR 1,4 million over the period 2018-2023, compared to management in-house, increase efficiency and flexibility in the management of the initiative, provide simplification of procedures, increase proximity to the beneficiaries as well as visibility of Union funding. In order to ensure a rapid and smooth launch of the first call, the Agency will have to commit sufficient resources upfront. The amount necessary to cover the additional costs of the Agency for the launch of the WiFi4EU initiative in 2018 is estimated to EUR 724 123,15 in non-differentiated appropriations.
