In Annex IA to Regulation (EU) 2018/120, the fishing opportunities table for sandeel in Union waters of ICES divisions 2a and 3a and ICES subarea 4 is replaced by the following:

By-catches of whiting and mackerel counted against the quota pursuant to this provision and by-catches of species counted against the quota pursuant to Article 15(8) of Regulation (EU) No 1380/2013 shall, together, not exceed 9 % of the quota.

Special condition: within the limits of the abovementioned quotas, no more than the quantities given below may be taken in the following sandeel management areas, as defined in Annex IID:
