The Presidency concluded that without an agreed EU position on the negotiations of the Global Compact for Migration, the EU Delegation in New York cannot speak on behalf of the EU. The fact that there is an EU common policy and EU acquis on most of the issues raised in the Global Compact is not in itself sufficient, since the context and the material content are not the same.

In practice, this means that:

- the EU Delegation in New York should continue to facilitate the coordination of positions among Member States, but cannot take the floor at the actual negotiation rounds;
- the current text of the Framework Document (which has the agreement of 27 Member States) may serve as an informal basis for the interventions of Member States, in their national capacity, until there is a consensus on an EU position; equally those Member States may designate one of them to speak on their behalf provided that it is clear that they are not speaking in an EU capacity;
- in their national interventions, Member States cannot, under the principle of sincere cooperation provided for in the Treaty, express positions that are contrary to the EU common policy and EU acquis.

Statement by France

"Depuis le début des discussions en Conseil, la France a exprimé sa préoccupation sur le développement de la pêche électrique. En effet, cette technique de pêche affecte à la fois les écosystèmes marins et les stocks de poissons, ciblés et accessoires. En outre, la technique de pêche au chalut électrique fait l'objet en France d'une vive opposition qui associe les milieux économiques, les organisations de la société civile et le monde politique.

La France mesure les efforts menés par la Présidence pour parvenir à la meilleure défense de la position du Conseil. Elle souhaite cependant rappeler son soutien aux amendements adoptés par le Parlement européen en session plénière visant à l'interdiction du chalut électrique dans le cadre de la révision du règlement Mesures techniques."

Statement by Germany

"Germany is supportive of the mandate for the further trilogue negotiations on the proposal on technical measures. However, from the German point of view one important element is not duly reflected in the mandate:

For the amendment proposals 306, 314, 315, 356 on pulse fishery we generally support the starting point of the General Approach (GA) insofar as scientific studies show a certain potential of the pulse fishery for a less harmful fishing technique. This is in particular the case when using this technique in the shrimp fishery. For the use of this technique in flatfish fisheries, further studies are needed for a final assessment. However, the assessment foreseen in Article 7(b) for a delegated act according to Article 18 should not only cover the potential benefits for the conservation of marine biological resources (as currently in the GA) but pursue a holistic approach by covering also the overall environmental impact, including non-target species and sensitive habitats. Broadening the scope of the assessment in this way could also help to accommodate the European Parliament on this issue without putting into question the possibility of pulse fishery as such.

Germany will continue the discussion of this issue on this basis but is prepared to continue the trilogue on the basis of the proposed text at this stage."

Statement by Hungary

"14) STRESSES, against the background of recommendation 1b) of the Court, that the Commission should explore how the role of ex-ante conditionality in implementing relevant reforms could be enhanced for the period post-2020; RECALLS its position set out in Council conclusions of November 2016 that more consistency should be sought for in the future between various measures linking the effectiveness of the ESI Funds to economic governance, building on the lessons learned from the introduction of ex-ante conditionalities;

The firm position of Hungary is that the link between Cohesion Policy and the European Semester is already strong enough (stronger than ever), and there is no need to further strengthen it. The fundamental objective of Cohesion Policy is to support economic convergence, therefore the implementation of relevant reforms shall not be considered as a final aim, rather a tool.

Ex-ante conditionalities regarding Cohesion Policy are only acceptable for Hungary if they are related to its substantive and procedural provisions in the Treaties, instead of serving the realisation of other EU policy objectives.

In view of the compromise, Hungary supports the Council Conclusions on Special Report No 15/2017 by the European Court of Auditors on "Ex ante conditionalities and performance reserve in Cohesion: innovative but not yet effective instruments" and its paragraph (14), if it does not exceed the current framework and does not establish any obligations to Member States regarding the post 2020 period. In our view the leeway should be kept for Member States to decide on their own which reforms and measures can promote the best the cohesion objectives."
