I would kindly ask you to initiate the appointment procedure laid down in Article 305 TFEU for the following new nomination to the Committee of the Regions (CoR):

The Board of the *Deutscher Städtetag* (German Association of Cities) has nominated Dr Peter Kurz, *Oberbürgermeister* of the city of Mannheim, as a full member of the CoR for the remainder of its sixth term of office. The nomination was necessitated by the resignation of Mr Joachim Wolbergs, *Oberbürgermeister* of the city of Regensburg.

The Federal Government hereby proposes that Dr Peter Kurz be appointed as a full member of the CoR for its sixth term of office.
