Having regard to the Treaty on the Functioning of the European Union, and in particular Article 91, Article 100(2), Articles 207 and 211, in conjunction with point (a) of the second subparagraph of Article 218(6) thereof,

Having regard to the Act of Accession of the Republic of Croatia, and in particular Article 6(2) thereof,

Having regard to the proposal from the European Commission,

Having regard to the consent of the European Parliament¹,

Whereas:

- The Economic Partnership, Political Coordination and Cooperation Agreement between (1) the European Community and its Member States, of the one part, and the United Mexican States, of the other part¹ (the 'Global Agreement'), was signed on 8 December 1997 and entered into force on 1 October 2000.
- (2) In accordance with Article 6(2) of the Act of Accession of the Republic of Croatia, the accession of Croatia to the Global Agreement is to be agreed by means of a protocol to the Global Agreement concluded between the Council, acting unanimously on behalf of the Member States, and the United Mexican States.

- (3) On 14 September 2012, the Council authorised the Commission to open negotiations with the United Mexican States with a view to concluding the Third Additional Protocol to the Global Agreement to take account of the accession of the Republic of Croatia to the European Union (the 'Protocol'). The negotiations were successfully concluded and the Protocol was signed in accordance with Council Decision (EU) 2018/...¹⁺ on ...⁺⁺.

Article 1

The Third Additional Protocol to the Economic Partnership, Political Coordination and Cooperation Agreement between the European Community and its Member States, of the one part, and the United Mexican States, of the other part, to take account of the accession of the Republic of Croatia to the European Union is hereby approved on behalf of the Union and its Member States.¹

Article 2

The President of the Council shall, on behalf of the Union and its Member States, give the notification provided for in Article 5(2) of the Protocol.²

Article 3

This Decision shall enter into force on the date of its adoption.
