Statement by Belgium, Denmark, Finland, France, Germany, Ireland, Italy, the Netherlands, Portugal, Slovenia and Spain

"The following Member States, Belgium, Denmark, Finland, France, Germany, Ireland, Italy, the Netherlands, Portugal, Slovenia and Spain acknowledge this amendment aims to clarify Regulation 1380/2013. This amendment restricts the extension of discard plans to just three years, whereas these Member States wish to have a longer extension possibility. Because of time constraints the Member States decided to support the Commission proposal."
