	- Discussion of Council conclusions

Following the tasking by the Permanent Representatives Committee¹, at its meetings of 27 April and 28 May 2018 the Energy Working Party discussed the European Court of Auditors' Special Report 05/2018² entitled "Renewable energy for sustainable rural development: significant potential synergies, but mostly unrealised" as well as draft Council conclusions on the European Court of Auditors' Special Report.

The Presidency revised the draft Council conclusions as set out in the Annex. Changes to the previous draft Council conclusions are market as **bold underlined**.
