Presentation from the Commission

The SCA took note of the presentation made by the Commission of its proposal and of the questions for clarification raised by one delegation. It also took note of the silence procedure set by the Presidency for Member States to inform the Council Secretariat, by Wednesday 13 June noon¹, in the event that they could not support the Commission proposal.

6. Organisation of future work

The Presidency informed the SCA on the "Agriculture and Fisheries" Council meeting on 18 June 2018 and on the Workshop meeting of the EU Rural Development Network on 21-22 June 2018 in Sofia.

The incoming Austrian Presidency informed the SCA on the planned meeting dates until September 2018 for the Working Parties on Horizontal Agricultural Questions, Agricultural Products and Agricultural Financial Questions, and that a detailed planning of discussions on the CAP reform in these Working Parties would soon be circulated.²

The Cyprus delegation confirmed their intention to table an AOB item at the "Agriculture and Fisheries" Council meeting on 18 June 2018, on the decreasing availability of water for agriculture in their country³.
