3. **Contract Law-Sales of Goods Directive**

IC 9261/18

Policy debate

The Council held a policy debate on the questions set out in document 9261/18.

The debate showed a clear and strong wish of the Council to apply one single set of rules, namely the sales of goods rules, to all consumer goods, including goods which incorporate digital content or digital services ('smart goods'). Ministers stressed the importance of simple rules that are easy to apply in practice and that are technologically neutral and future-proof.

As regards the remedies available to the consumer in the event of a lack of conformity and the level of harmonisation with regard to the length of the legal guarantee period, the Council confirmed that the compromises found on the draft Digital Content Directive would be a good starting point for the further discussions on the sales of goods proposal. It was also pointed out that adaptations should be made where justified by the different nature of goods.

Partial general approach

The Council agreed on the partial general approach as set out in document 9236/18 ADD1 and took note of a statement by Germany to this item as set out in the Annex.

The Council held a policy debate (document 8886/18) on the topics of the circulation of provisional, including protective, measures, the placement of children in another Member State and how to achieve the complete abolition of exequatur. Ministers broadly supported the further strengthening and improvement of the rules on the first and second topic of discussion and showed enough support to continue the work to find a compromise at technical level on the third topic.

Ad "B" item 4: **Directive on Insolvency, restructuring and second chance**
 Partial general approach

STATEMENT BY GERMANY

"Germany believes that the European legal framework to be created for insolvency must be capable of making significant contributions to reducing and preventing non-performing loans. In particular, the collection of data on recovery rates foreseen in Title V (Article 29 para. 1b) should be obligatory for all Member States in order to allow a comparison of the efficiency of insolvency proceedings in the context of the banking union."
