- <u>The General Secretariat of the Council</u> has been informed of the resignation of Mr Frédéric TEZE as alternate member of the above Committee in the governments' representatives category (for France).
- 2. Under Article 3 of Decision 2003/C 218/01, members and alternate members are appointed by the Council.

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Council Decision 2003/C 218/01 of 22 July 2003¹ on the setting up of an Advisory Committee on Safety and Health at Work, and in particular Article 3 thereof,

Whereas:

- In its Decision of 24 February 2016² the Council appointed the members and alternate members of the Advisory Committee on Safety and Health at Work for the period ending on 28 February 2019.
- (2) A seat as alternate member in the governments' representatives category has fallen vacant as a result of the resignation of Mr Frédéric TEZE.
