Subject:	Council Decision on the position to be taken on behalf of the European Union in the Joint Committee established by the Agreement between the European Union and the Swiss Confederation on the linking of their greenhouse gas emissions trading systems regarding the adoption of its Rules of Procedure — Adoption

1. On 4 June 2018, the <u>Commission</u> submitted the above-mentioned proposal for a Council Decision on the position to be taken on behalf of the European Union in the Joint Committee established by the Agreement between the European Union and the Swiss Confederation on the linking of their greenhouse gas emissions trading systems regarding the adoption of its Rules of Procedure¹.

- 2. The aim of the Agreement between the European Union and the Swiss Confederation on the linking of their greenhouse gas emissions trading systems ('the Agreement')² is to connect the Emissions Trading Systems of the EU and Switzerland, by allowing that allowances issued in one system can be traded and used for compliance in the other one.
- 3. The <u>Council</u> adopted on 10 November 2017 Decision (EU) 2017/2240 on the signing, on behalf of the Union, and provisional application of the Agreement between the European Union and the Swiss Confederation on the linking of their greenhouse gas emissions trading systems³. The Agreement was signed on 23 November 2017.
- 4. The <u>Council</u> adopted on 23 January 2018 Decision (EU) 2018/219 on the conclusion of the Agreement⁴. It will enter into force on 1 January of the year following the exchange of the instruments of ratification or approval by the Parties. The instrument of approval of the EU will be notified when the Swiss Confederation has brought into force the requisite rules extending its ETS to aviation and Annex I of the Agreement has been amended accordingly.
- 5. However, the provisions of the Agreement in relation to the Joint Committee, which is responsible for its implementation, apply provisionally from the date of signature, and the first meeting of the Joint Committee must take place by the end of 2018.
- 6. The Working Party on the Environment (WPE) examined the Commission proposal on 5 and 22 June 2018. Based on the discussions in the WPE and delegations' comments, the Presidency prepared a Presidency compromise proposal⁵ which was agreed by the WPE on 5 July following an informal silence procedure.
