	Appointment of Mr Radan ŠAFAŘÍK , member for Czech Republic, in place of Ms Andrea BARŠOVÁ, who has resigned

- 1. The General Secretariat of the Council has been informed of the resignation of Ms Andrea BARŠOVÁ as member of the Management Board of the European Institute for Gender Equality in the government representatives category (for Czech Republic).
- Article 10 of Regulation (EC) No 1922/2006 of 20 December 2006<sup>1</sup> provides, inter alia, that 2. the Council should appoint 18 members, as well as alternates, of the Management Board of the European Institute for Gender Equality for a period of three years.
