Sir,

I am pleased to inform you that Mr Oliver Schenk, Chef der Staatskanzlei und Staatsminister für Bundes- und Europaangelegenheiten, has taken over the mandate as an alternate member of the CoR for the Free State of Saxony.

The nomination has been necessitated by the fact that the previous alternate member of the CoR, Dr Fritz Jaeckel, is no longer a member of the Government of the State of Saxony.

Due to the formation of a new government and other organisational restructuring measures in the Free State of Saxony, it was first necessary to coordinate on an internal level regarding the filling of positions in the CoR.

In the meantime, the Council of the European Union has also confirmed the termination of Dr Fritz Jaeckel's term of office as an alternate member of the CoR as a result of his resignation from ministerial office.

I would ask you to forward the nomination to the Ministry of Foreign Affairs as soon as possible in order to enable the Council of the European Union to appoint Staatsminister Oliver Schenk without delay. The information necessary for the nomination is enclosed with this letter.
