**DRAFT COUNCIL DECISION**  
**APPOINTING THE MEMBERS**  
**OF THE SCIENTIFIC AND TECHNICAL COMMITTEE**

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty establishing the European Atomic Energy Community, and in particular Article 134(2) thereof,

After consulting the European Commission,

Whereas:

- (1) Article 134(2) of the Treaty, as amended by Article 11 of the Act of Accession of Croatia, provides for the Members of the Scientific and Technical Committee to be appointed by the Council in their personal capacity for five years.
- (2) By the Decision of 22 July 2013<sup>1</sup>, the Council appointed the members of the Scientific and Technical Committee for the period from 25 July 2013 to 24 July 2018. As the term of office of the members of the Committee has come to an end, new members of the Committee should be appointed.
- (3) In order to make full use of the wide range of expertise required to fulfil its tasks, the Scientific and Technical Committee may, subject to its internal rules, call on alternates to the members to participate in its meetings,
