THE COUNCIL OF THE EUROPEAN UNION,

Having regard to Council Regulation (EEC) No 337/75 of 10 February 1975 establishing the European Centre for the Development of Vocational Training¹, and in particular Article 4 thereof,

Having regard to the lists of nominees submitted to the Council by the Governments of the Member States as regards their representatives, and by the Commission as regards the employees' and employers' representatives,

Whereas:

- By Decisions of 14 July 2015² and 14 September 2015³, the Council appointed the members of the Governing Board of the European Centre for the Development of Vocational Training (the 'Centre') for the period from 18 September 2015 to 17 September 2018.
- (2) The Commission submitted one nominee as regards the employees' representatives.
- (3) The Governments of Slovakia and Spain submitted two nominees as regards the government representatives.
