COUNCIL DECISION

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) No 492/2011 of the European Parliament and of the Council of 5 April 2011 on freedom of movement for workers within the Union¹, and in particular Articles 23 and 24 thereof,

Having regard to the lists of candidates submitted to the Council by the Governments of the Member States,

Whereas:

- (1) By its Decisions of 20 September 2016¹, of 14 November 2016², of 28 November 2016³, of 23 January 2017⁴, of 27 March 2017⁵, of 23 January 2018⁶ and of 16 April 2018⁷, the Council appointed the members and alternate members of the Advisory Committee on Freedom of Movement for Workers (the 'Committee') for the period from 25 September 2016 to 24 September 2018.
- (2) The members should remain in office until they are replaced or reappointed.
- (3) Members and alternate members of the Committee should be appointed for a period of two years,
