Subject: Management Board of the European Institute for Gender Equality:  
Appointment of Ms H el ene FURNON-PETRESCU, member for France, in  
place of Ms St ephane SEYDOUX, who has resigned

---

1. The General Secretariat of the Council has been informed of the resignation of Ms St ephane SEYDOUX as member of the Management Board of the European Institute for Gender Equality in the government representatives category (for France).
2. Article 10 of Regulation (EC) No 1922/2006 of 20 December 2006<sup>1</sup> provides, inter alia, that the Council should appoint 18 members, as well as alternates, of the Management Board of the European Institute for Gender Equality for a period of three years.

3. The eighteen members and alternate members appointed by the Council represent eighteen Member States in the order of the rotating Presidencies, one member and one alternate member being nominated by each Member State.
