1. The General Secretariat of the Council has been informed of the resignation of Ms Susanna RIBRANT as member of the Governing Board of the above Foundation in the governments' representatives category (for Sweden).
2. Under Article 6 of Regulation (EEC) No 1365/75, as amended by Regulation (EC) No 1111/2005, members and alternate members of the Governing Board are appointed by the Council.

3. In accordance with the usual procedure, the government of Sweden has nominated the following candidate to replace the resigning member for the remainder of the current term of office, ending on 30 November 2019:

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Council Regulation (EEC) No 1365/75 of 26 May 1975 on the creation of a European Foundation for the Improvement of Living and Working Conditions<sup>1</sup>, and in particular Article 6 thereof,

Whereas:

- (1) In its Decision of 28 November 2016<sup>2</sup>, the Council appointed the members and alternate members of the Governing Board of the European Foundation for the Improvement of Living and Working Conditions for the period ending on 30 November 2019.
- (2) A seat as member of the Governing Board of that Foundation in the governments' representatives category has fallen vacant as a result of the resignation of Ms Susanna RIBRANT.
- (3) the government of Sweden has submitted a nomination for the vacant seat,
