The EU contributions actually paid to the International Sugar Organisation, the International Grains Council and the International Olive Council were lower than estimated in the 2018 budget and therefore an amount of EUR 1,8 million will not be used

Moreover, the World Intellectual Property Organisation will not use the amount of EUR 1,0 million budgeted in 2018, as the adoption procedure for the Commission proposals for EU accession to the Geneva Act of the Lisbon Agreement (Council Decision on accession and European Parliament and Council Regulation on implementation of accession) took substantially longer than anticipated. The legislative procedure for both proposals in the European Parliament and Council will not be terminated before year's end. In total, EUR 2,8 million can be made available.

d) Detailed grounds for the transfer

The Commission proposes to reinforce the European Neighbourhood Instrument (ENI) budget with EUR 20 million in commitment appropriations in order to provide an additional contribution to the Programme Budget of the United Nations Relief and Works Agency for Palestine refugees in the Near East (UNRWA) and help sustain the Agency's operations until the end of 2018.

This additional contribution is granted in light of the earlier reduction of the United States' contribution to UNRWA by USD 300 million, which has resulted in a major financing gap for the institution. This gap currently stands at USD 217 million in total, with USD 123 million under the Programme Budget and USD 94 million under the Emergency Appeal. Without additional contributions, UNRWA runs the risk of not being able to maintain essential operations until the end of the year.

UNRWA's operations provide a critical lifeline for millions of Palestine Refugees. The continuing support to the Agency is a key element in the EU's strategy of contributing to the promotion of stability in the Middle East and for the viability of the two-state solution. This support is particularly relevant in the context of the migration challenges, as well as EU efforts to prevent radicalisation.

The EU has contributed annually to UNRWA's Programme Budget since 1971. For the period 2018-2020, contributions to UNRWA's Programme Budget are framed by the EU-UNRWA Joint Declaration, jointly signed in Brussels on 7 June 2017 by Commissioner Hahn, HRVP Mogherini and UNRWA Commissioner-General Krähenbühl. Though not mentioning the level of EU financial support, this agreement provides the agency with the much needed predictability of EU support in sustaining its core programmes. The EU contribution to UNRWA Programme Budget for the period 2018-2020 amounts to EUR 249 million.

When granting this extraordinary additional support to UNRWA, the EU will emphasise the need to make further efforts to reform both the revenue and expenditure sides of the Agency's budget.

Additional payment appropriations are not requested as the needs can be met by the available appropriations in the ENI budget.
