MANDATE OF THE SFIC AD HOC WORKING GROUP FOR A BENCHMARKING EXERCISE ON STRATEGIES AND ROADMAPS FOR INTERNATIONAL COOPERATION IN R&I

1. In view to develop appropriate joint strategic approaches and actions for international R&I cooperation in line with the ERA roadmap- priority 6, the SFIC ad hoc working group for a benchmarking exercise on strategies and roadmaps for international cooperation in R&I - hereafter the "INCO benchmarking WG" - has the <u>objective</u> to carry out a benchmarking of national initiatives, frameworks and roadmaps in EU Member States and Associated Countries for R&I cooperation with third countries.

Where relevant, the INCO benchmarking WG will benefit from the Toolbox Working Group's gathered information/data concerning roadmaps/strategies and will make full use of its deliverables.

- 2. The INCO benchmarking WG will focus in particular on the following <u>activities</u>:
 - a) To collect and to map out the various approaches in the drafting of national roadmaps and strategies for international cooperation in R&I, i.e. countries, perimeter, themes, etc.;
 - b) To compare the different approaches, i.e. motivation, process, timeframe, priorities, indicators, existence of international benchmarking processes, etc.;
 - c) To identify transferrable good practice and joint approaches where relevant, i.e. synergies between countries and/or the EU, innovative approaches, etc.
- 3. The INCO benchmarking WG will provide the following <u>deliverables</u>:
 - a) Survey and comparative report on national approaches on international strategies in R&I;

- b) Identification of key elements in support of priority 6 of ERA;
- c) Draft SFIC opinion on international strategies in R&I.
- 4. The INCO benchmarking WG is set up for a period of <u>12 months</u>, commencing on [26 September 2018].
- 5. The SFIC Rules of Procedure (doc. ERAC-SFIC 1355/16) are applicable to the INCO benchmarking WG.
