Having regard to Council Regulation (EEC) No 337/75 of 10 February 1975 establishing a European Centre for the Development of Vocational Training<sup>1</sup>, and in particular Article 4 thereof,

Having regard to the lists of nominees submitted to the Council by the Governments of the Member States as regards their representatives, and by the Commission as regards the representatives of the employers' organisations and employees' organisations,

Whereas:

- (1) By its Decision of 16 July 2018<sup>2</sup> and Corrigendum to Council Decision of 16 July 2018<sup>3</sup>, the Council appointed the members of the Governing Board of the European Centre for the Development of Vocational Training for the period from 18 September 2018 to 17 September 2021.
