Brexit

The Council, in an EU27 format, was informed by the Commission's chief Brexit negotiator, Michel Barnier, of the progress made so far in the negotiations with the UK after six rounds of talks. The delegations of the 27 member states took note of the state of play. Ministers also started preparations for the European Council (Article 50) of December 2017 with a discussion on the annotated draft agenda for the summit ([XT 21093/17](#)).

– Agencies

In the margins of the meeting of the General Affairs Council (Article 50), ministers selected the new seats for the two EU agencies currently based in the UK which need to be relocated in the context of Brexit. Amsterdam (The Netherlands) was selected as the new location for the European Medicines Agency (EMA) and Paris (France) for the European Banking Authority (EBA).
