Statement by Bulgaria

"Bulgaria thanks the Austrian Presidency for the efforts to find a compromise solution.

In a spirit of compromise and willing to support a European Union speaking in one voice at FCTC, we do not oppose the proposed Draft position and Draft decision.

At the same time, Bulgaria considers that the suggested wording in particular in p. h) on the last page of Annex III to the proposed Draft decision is incorrect and might lead to misleading perception among the international community about the status-quo within the EU.

Conformity with the *acquis communautaire* is of significant importance when the Union – and not the single Member States - are speaking in an international setting. This is a reliable guarantee for Member States which contributes to a relationship based on trust but also to an endorsement by all Member States of the position expressed.

This principle is not attained in p. h) on the last page of Annex III to the proposed Draft decision, which concerns novel tobacco products such as heated products. Bulgaria considers ***that the direct invitation to “restrict or ban” those products is not originating from the EU acquis***, which:

- a) leaves it at the discretion of the Member States to regulate the matter as they see fit – i.e. there are no harmonized rules introducing a ban or restrictions within the Union;
- b) allows for a regulation – but does not encourage a ban (see Art. 19, art. 24 (3) of TPD). “Regulation” can take up different forms, with prohibition being an option, in case it is a needed and proportionate measure, based on scientific evidence, and genuinely intended to protect public health.

Furthermore, not a single Member State of the EU has introduced a ban or restrictions of production, distribution etc. of heated products. It is, therefore, misleading to encourage others to do so.

Therefore, Bulgaria would support the proposal to replace the words “restrict or prohibit” with “regulate” in p. h) on the last page of Annex III.

Bulgaria supports the endeavor to find a common position based on consensus provided that the final decision adopted at FCTC, which is initiated by the European Union, remains within the mandate given and the red lines introduced by the Presidency are kept:

- The words “*in accordance with national law*” are preserved throughout the text, in order to make clear that despite the common legal framework at Union level, specific legislation is a national competence;
- The words “*as appropriate*” are kept, thus making clear that it is at the discretion of the Member States to assess the need of regulation, including the need for a ban;

It should also be a red line that *any ban or restrictions are based on grounds relating to the specific situation in particular Member State and provided that they are justified by scientific evidence for the need to protect public health.*

We are convinced that regardless of amendments introduced in the document during the negotiating process at international level, these safeguards can be justified, defended and kept in the text. Therefore, *we consider them to be red lines in the mandate provided to the Commission.* Their deletion would mean loss of consensus among the EU Member States on the proposed draft decision, and have as consequence the need of withdrawal of the draft decision.

As the statements and commitments within the FCTC of WHO are of broad political nature Bulgaria underlines that the EU commitments under FCTC should not be fulfilled only in virtue of the discussions and documents produced by COPs, but also on grounds relating to the specific situation in individual EU Member States."

Statement by Italy

"Italy thanks the Austrian Presidency for all its efforts to find a compromise solution.

In a spirit of compromise and willing to support the European Union speaking in one voice at COP8/FCTC in Geneva, Italy will support a compromise text of an EU common position on point 4(h) of Annex III in document 6.3 of FCTC agreed by all Member States, provided that in this final compromise text of the EU common position the words “*as appropriate to their national laws,*” are preserved throughout the text, in order to make clear that despite the common legal framework at Union level, specific legislation is a national competence.

Directive 2014/40/EU, of the European Parliament and of the Council, in Article 24.3 stipulates that Member States may also prohibit a certain category of tobacco or related products, on grounds relating to the specific situation in that Member State and provided the provisions are justified by the need to protect public health, taking into account the high level of protection of human health achieved through this Directive. The Commission shall approve or reject such national provisions, after having verified also whether or not they are justified, necessary and proportionate to their aim and whether or not they are a means of arbitrary discrimination or a disguised restriction on trade between the Member States.

We believe it is in the shared interest of all Member States and their citizens to achieve an EU common position on this point 4(h) of Annex III in document 6.3 of FCTC, so that the European Union can speak in one voice at FCTC in Geneva."

Statement by Germany

"Germany thanks the Presidency for its efforts to reach consensus on document 12283/18 (EU coordination document on FCTC 6.3). In the spirit of compromise we can accept the document as it stands. However, we think that in Annex III 4 h the words "restrict or prohibit" and in 4 d the words "restrict or ban" are not appropriate. We consider the word "regulate" to be more appropriate in both cases; the aforementioned wording should be replaced accordingly. Therefore we propose to come back to that issue in the EU coordination on the spot during COP 8 of FCTC in Geneva taking into account the discussions with all FCTC members."

"In Germany's view, the uniform retention period of five years provided for in Article 13(4) appears problematic, because data may also be collected on individuals who have not violated any rules and who themselves have not given any cause for their data to be stored. It would therefore have been preferable for Article 13(4) to differentiate between retention periods for suspicious and non-suspicious individuals. However, Germany welcomes the compromise that was reached during the negotiations whereby the permissible one-off extension of the retention period is limited to three years in accordance with Article 13(5)."

Statement by Germany

"Germany assumes that the German version of the recitals will be corrected as follows:

In recital 1 the expression "fortpflanzungsgefährdend" will be changed to "reproduktionstoxische Stoffe".

In recital 2 the expression "für einen Beschränkungs-vorschlag" will be added after "Dossier".

In recital 3 the expression "der Agentur" is deleted after "Ausschuss für Risikobeurteilung (RAC)" and added after "Ausschuss für sozioökonomische Analyse (SEAC)".

In recital 4 the expression "die Einführung" is replaced by "das Einbringen".

In recital 5 the word "wird" is replaced by "würde" in the first sentence. The second sentence is changed to "Dieser Konzentrationsgrenzwert würde wirksam die Verwendung der vier Phthalate in Erzeugnissen im Geltungsbereich dieser Beschränkung verhindern".

Recital 6 is changed to "Am 10. März 2017 verabschiedete der RAC seine Stellungnahme mit der Schlussfolgerung, dass die vorgeschlagene Beschränkung im Hinblick auf die Wirksamkeit bei der Verringerung dieser Risiken die zweckmäßigste unionsweite Maßnahme zur Bewältigung der festgestellten Risiken darstellt, die von diesen Stoffen ausgehen".

In recital 8 the expression "bei einer sozioökonomischen Kosten/Nutzen-Abwägung" is changed to "im Hinblick auf die sozio-ökonomischen Nutzen und Kosten".

In recital 9 the third sentence is changed as follows: "Außerdem schlug der SEAC aufgrund sozioökonomischer Überlegungen basierend auf mit zusätzlichen Informationen, die von der Automobil- und Luftfahrtbranche im Rahmen der öffentlichen Konsultation eingereicht wurden, bestimmte Ausnahmeregelungen für diese Branchen vor".

In recital 10 the word "Beschränkungsverfahren" is changed to "Beschränkungs-vorschlag".

In recital 11 the word "auswirkten" is changed to "auswirkt" in the second sentence. In the third sentence the word "können" is added after the word "enthalten". In the fourth sentence "Verkleidungen" is changed to "Lackierungen" and "Klebeschichten" to "Aufklebern".

The first sentence of recital is replaced by the following sentence: “Nach Anhang XVII der Verordnung (EG) Nr. 1907/2006 ist das Inverkehrbringen von Spielzeug und Babyartikeln, die DEHP, DBP und /oder BBP enthalten, unter bestimmten Bedingungen bereits verboten, diese fallen in den Anwendungsbereich der vorgeschlagenen Beschränkung”. Furthermore, in the second sentence “DIPB“ is corrected to “DIBP“.

In the last sentence of recital 13 the “n“ is deleted at the end of the word “menschlichen“.

In recital 15 the word “Entwurfsspezifikationen“ is changed to “Konstruktionspezifikationen“.

In the first sentence of recital 16 “Belastung“ is changed to “Belastungen“.

Furthermore, the second row of the entry itself will be changed as follows:

Paragraph 1 is changed to: “Dürfen nicht als Stoffe oder in Gemischen einzeln oder in einer Kombination der in Spalte 1 dieses Eintrags aufgeführten Phthalate in Spielzeug und Babyartikeln verwendet werden, wenn diese Konzentration mindestens 0,1 Gewichtsprozent des weichmacherhaltigen Materials ausmacht.“

Paragraph 2 is changed to: “Dürfen nicht in Spielzeug oder Babyartikeln auf den Markt gebracht werden, wenn die Konzentration einzeln oder eine Kombination der ersten drei der in Spalte 1 dieses Eintrags aufgeführten Phthalate mindestens 0,1 Gewichtsprozent des weichmacherhaltigen Materials ausmacht.

Ferner darf DIBP nach dem [Amt für Veröffentlichungen: bitte Datum einfügen: 18 Monate nach Inkrafttreten] nicht in Spielzeug oder Babyartikeln in Verkehr gebracht werden, wenn seine Konzentration einzeln oder in Kombination mit den ersten drei der in Spalte 1 dieses Eintrags aufgeführten Phthalate mindestens 0,1 Gewichtsprozent des weichmacherhaltigen Materials ausmacht.“

In paragraph 3 the expression “dieses Eintrags“ is added after “in Spalte 1“.

In paragraph 4 letter b and c the “und“ in “Wartung und Reparatur“ is replaced by an “oder“. In paragraph 4 letter c also the expression “vom Zeitpunkt des Inverkehrbringens“ is added after the word “unabhängig“.

In paragraph 4 letter g the “und“ is changed to “oder“.

In paragraph 5 letter a the word “Verkleidungen“ is changed to “Lackierungen“ and the word “Klebeschichten“ to “Aufkleber“.

Paragraph 5 letter b is changed to “ ‘für längere Zeit mit der menschlichen Haut in Berührung kommen‘ bezeichnet einen dauerhaften Kontakt von mehr als 10 Minuten oder wiederholte Berührungen über einen Zeitraum von 30 Minuten pro Tag“.
